## REQUEST FOR INFORMATION – INFORMATION RELATING TO "RING OF STEEL" SECURITY CORDON AROUND BELFAST CITY CENTRE DURINGTHE NORTHERN IRELAND CONFLICT – 1972-1994

Thank you for your e-mail dated 22 January, I can confirm that your request has been considered under the provisions of the Freedom of Information Act 2000 (FOI (A)), and the process is now complete.

You asked for the following:

"I am an independent researcher gathering information about the "Ring of Steel" security cordon placed around Belfast city centre during the Northern Ireland conflict 1972-1994.

Please can you provide information on the following:
Was the MoD responsible for taking the decision to erect the security cordon?
If so, when was this decision made?
Was the MoD responsible for erecting and manning the cordon?
If so, during which period?
Was responsibility for the cordon passed to other authorities?
If so, to whom and when?"

Whilst we may have some information it has been estimated that the cost of complying with your request would exceed the appropriate limit and therefore under the terms of Section 12(2) of the FOI(A), we are not obliged to comply. The appropriate limit is specified in regulations and for central government this is set at £600. This represents the estimated cost of one person spending three and a half working days in determining whether the Department holds the information, locating, retrieving and extracting it. Thousands of records would need to be reviewed therefore we are unable to quantify how long it would take to process.

As previously explained under Section 16 of the FOI(A) (Duty to provide advice and assistance), I can advise that The Public Records Office (PRONI) and The National Archives (TNA) may hold information that could be of relevance to your request.
