



Figure 2: Q1 – table of responses



Figure 3: Q1 - all official responses





Figure 4: Q1 - personal responses








Figure 10: Q2 – table of responses



Figure 11: Q2 - all official responses





Figure 12: Q2 - all personal responses










Figure 16: Q2 - responses according to student's reasonable adjustments





Figure 18: Q3 - table of responses




Figure 21: Q3 - responses according to student's year group








Figure 26: Q4 – table of responses









Figure 29: Q4 - Responses according to student's year group




Figure 31: Q4 - responses according to student's disability





Figure 34: Q5 - table of responses







Figure 37: Q5 - responses according to student's year group



Figure 38: Q5 - responses according to student's ethnicity









Figure 42: Q6 - table of responses







Figure 45: Q6 - responses according to student's year group






Figure 48: Q6 - Responses according to student's reasonable adjustments





Figure 50: Table of Q8 - overall responses







Figure 53: Q8 - Responses according to student's year group




Figure 55: Q8 - Responses according to student's disability




Figure 58: Q9.1 - table of responses








Figure 61: Q9.1 - Responses according to student's year group






Figure 66: Q9.2 - table of responses









Figure 69: Q9.2 - responses according to student's year group






Figure 74: Q9.3 - table of responses







Figure 77: Q9.3 - responses according to student's year group






Figure 82: Q9.4 - table of responses









Figure 85: Q9.4 - responses according to student's year group




Figure 88: Q9.4 - responses according to student's reasonable adjustments





Figure 90: Q9.5 - table of responses







Figure 93: Q9.5 - responses according to student's year group






Figure 98 - Q10 - Table of responses








Figure 101: Q10 - responses according to student's year group





Figure 103: Q10 - responses according to student's disability





Figure 106: Q11 - table of responses






Figure 109: Q11 - responses according to student's year group





Figure 111: Q11 - responses according to student's disability




Figure 112: Q11 - responses according to student's reasonable adjustments





Figure 114: Q12 - table of responses






Figure 117: Q12 - responses according to student's year group






Figure 119: Q12 - responses according to student's disability





Figure 122: Q13 - table of responses






Figure 125: Q13 - responses according to student's year group






Figure 127: Q13 - responses according to student's disability





Figure 130: Q15 - table of responses






Figure 133: Q15 - responses according to student's year group






Figure 135: Q15 - responses according to student's disability





Figure 138: Q16 - table of responses






Figure 141: Q16 - responses according to student's year group






Figure 143: Q16 - responses according to student's disability





Figure 146: Q17 - table of responses






Figure 149: Q17 - responses according to student's year group







Figure 154: Q18 - table of responses






Figure 157: Q18 - responses according to student's year group







Figure 162: Q20 - table of responses






Figure 165: Q20 - responses according to student's year group






Figure 167: Q20 - responses according to student's disability





Figure 170: Q21 - table of responses






Figure 175: Q21 - responses according to student's disability





Figure 178: Q22 - table of responses






Figure 181: Q22 - responses according to student's year group






Figure 183: Q22 - responses according to student's disability





Figure 186: Q23 - table of responses






Figure 189: Q23 - responses according to student's year group






Figure 191: Q23 - responses according to student's disability





Figure 194: Q25 - table of responses






Figure 197: Q25 - responses according to student's year group






Figure 199: Q25 - responses according to student's disability





Figure 202: Q26 - table of responses






Figure 205: Q26 - responses according to student's year group






Figure 207: Q26 - responses according to student's disability:





Figure 210: Q28 - table of responses






Figure 213: Q28 - responses according to student's year group






Figure 215: Q28 - responses according to student's disability





Figure 218: Q29 - table of responses






Figure 221: Q29 - responses according to student's year group






Figure 223 : Q29 - responses according to student's disability





Figure 226: Q31 - table of responses






Figure 231: Q31 - responses according to student's disability





Figure 234: Q32 - table of responses






Figure 237: Q32 - responses according to student's year group






Figure 239: Q32 - responses according to student's disability





Figure 242: Q33 - table of responses






Figure 245: Q33 - responses according to student's year group






Figure 247: Q33 - responses according to student's disability





Figure 250: Q35 - table of responses






Figure 253: Q35 - responses according to student's year group







Figure 258: Q36 - table of responses






Figure 261: Q36 - responses according to student's year group







Figure 266: Q37 - table of responses






Figure 269: Q37 - responses according to student's year group







Figure 274: Q38 - table of responses






Figure 277: Q38 - responses according to student's year group







Figure 282: Q39 - table of responses






Figure 285: Q39 - responses according to student's year group






Figure 287: Q39 - responses according to student's disability





Figure 290: Q41 - table of responses






Figure 293: Q41 - responses according to student's year group






Figure 295: Q41 - responses according to student's disability





Figure 298: Q42 - table of responses






Figure 301: Q42 - responses according to student's year group






Figure 303: Q42 - responses according to student's disability





Figure 306: Q43 - table of responses






Figure 309: Q43 - responses according to student's year group






Figure 311: Q43 - responses according to student's disability





Figure 314: Q44 - table of responses






Figure 317: Q44 - responses according to student's year group







Figure 322: Q45 - table of responses






Figure 327: Q45 - responses according to student's disability





Figure 330: Q46 - table of responses






Figure 333: Q46 - responses according to student's year group






Figure 335: Q46 - responses according to student's disability





Figure 338: Q47 - table of responses






Figure 341: Q47 - responses according to student's year group






Figure 343: Q47 - responses according to student's disability





Figure 346: Q48 - table of responses






Figure 349: Q48 - responses according to student's year group







Figure 354: Q49 - table of responses






Figure 357: Q49 - responses according to student's year group






Figure 359: Q49 - responses according to student's disability





Figure 362: Q50 - table of responses






Figure 365: Q50 - responses according to student's year group






Figure 367: Q50 - responses according to student's disability





Figure 370: Q51 - table of responses






Figure 373: Q51 - responses according to student's year group






Figure 375: Q51 - responses according to student's disability





Figure 378: Q53 - table of responses






Figure 381: Q53 - responses according to student's year group






Figure 383: Q53 - responses according to student's disability





Figure 386: Q54 - table of responses






Figure 389: Q54 - responses according to student's year group






Figure 391: Q54 - responses according to student's disability





Figure 394: Q55 - table of responses






Figure 397: Q55 - responses according to student's year group






Figure 399: Q55 - responses according to student's disability





Figure 402: Q56 - table of responses






Figure 405: Q56 - responses according to student's year group






Figure 407: Q56 - responses according to student's disability





Figure 410: Q59 - table of responses






Figure 413: Q59 - responses according to student's year group






Figure 415: Q59 - responses according to student's disability





Figure 418: Q60 - table of responses







Figure 421: Q60 - responses according to student's year group


Figure 422: Q60 - responses according to student's ethnicity







Figure 426: Q61 - table of responses






Figure 429: Q61 - responses according to student's year group







Figure 434: Q63 - table of responses






Figure 437: Q63 - responses according to student's year group






Figure 439: Q63 - responses according to student's disability
