Thank you for your email of 23 March in which you requested the following information:

"In accordance with the Freedom of Information Act 2000, I would like to ask that you provide me with the following information regarding REME Artificers:

For the years 2017; 2018 and 2019:

1. The number of REME soldiers assessed at the Potential Artificer Assessment Board (PAAB) with a trade group breakdown.

2. The number of REME soldiers who passed the PAAB with a trade group breakdown. 3. The number of REME soldiers who were assessed at the Artificer Selection and Course Loading Board for artificer training by trade.

4. The number of REME soldiers who were selected for artificer training by trade.

5.he percentage of artificers promoted to WO2.

6. The percentage of artificers promoted to WO1."

I am treating your correspondence as a request for information under the Freedom of Information Act (FOIA) 2000. A search for the information has now been completed within the Ministry of Defence, and I can confirm that the information in scope of your request is held and is shown in the tables below.

Notes/Caveats to Tables 6-9

- Figures are for Trade Trained Regular strengths only and therefore exclude FTRS and Gurkhas but include those individuals who have transferred from GURTAM to UKTAP.
- Figures are using Paid Ranks only.
- Trades have been determined via the field Main Trade for Pay in the Army Administration database.
- Figures have been rounded to 10; numbers ending in "5" have been rounded to the nearest multiple of 20 to prevent systematic bias.
- Totals have been rounded separately and so may not appear to be the sum of their parts.
- Unrounded figures are used in the calculation of percentages.
- Table 6 and 7 represents the number of Artificers who gained promotion as a percentage of average strength of the rank being promoted from over the time period. For example, Table 1 shows the percentage of Artificer Staff Sergeants being promoted per year from the average strength from the average Artificer Staff Sergeant population in that year.
- Table 8 and 9 represents the proportion of REME WO2 promotions by Artisans and Artificers.
- "-" denotes zero or rounded to zero.
