## The Armed Forces Covenant

An Enduring Covenant Between

The People of the United Kingdom Her Majesty's Government

- and -

All those who serve or have served in the Armed Forces of the Crown

#### And their Families

The first duty of Government is the defence of the realm. Our Armed Forces fulfil that responsibility on behalf of the Government, sacrificing some civilian freedoms, facing danger and, sometimes, suffering serious injury or death as a result of their duty. Families also play a vital role in supporting the operational effectiveness of our Armed Forces. In return, the whole nation has a moral obligation to the members of the Naval Service, the Army and the Royal Air Force, together with their families. They deserve our respect and support, and fair treatment.

Those who serve in the Armed Forces, whether Regular or Reserve, those who have served in the past, and their families, should face no disadvantage compared to other citizens in the provision of public and commercial services. Special consideration is appropriate in some cases, especially for those who have given most such as the injured and the bereaved.

This obligation involves the whole of society: it includes voluntary and charitable bodies, private organisations, and the actions of individuals in supporting the Armed Forces. Recognising those who have performed military duty unites the country and demonstrates the value of their contribution. This has no greater expression than in upholding this Covenant.

### **Section 1: Principles of The Armed Forces Covenant**

- 1.1 We **QPR Solutions Ltd** will endeavour in our business dealings to uphold the key principles of the Armed Forces Covenant, which are:
  - no member of the Armed Forces Community should face disadvantage in the provision of public and commercial services compared to any other citizen
  - in some circumstances special treatment may be appropriate especially for the injured or bereaved.

#### **Section 2: Demonstrating our Commitment**

- 2.1 We recognise the value serving personnel, reservists, veterans and military families bring to our business and to our country. We will seek to uphold the principles of the Armed Forces Covenant, by:
  - Promoting the Armed Forces: promoting the fact that we are an Armed Forces-friendly organisation, to our staff, customers, suppliers, contractors and wider public by publicising our Covenant on our website and displaying the Covenant logo. We actively engage with clients to advise them that we are proud supporters of the armed forces covenant and actively try to help all veterans into employment where possible.
  - Veterans: supporting the employment of veterans, recognising military skills and qualifications in our recruitment and selection process; working with the Career Transition Partnership (CTP) to support the employment of Service leavers;

We do this by advising our clients we are part of the Armed Forces Covenant, explaining to them how we are helping support veterans nationwide.

Our branch in Cirencester will be holding monthly coffee and cake days for anyone to join – this is focused on ex-vets suffering from PTSD to come in, and have a safe environment to relax and talk in, and if they want, they can ask for recruitment help and advise

- Service Spouses & Partners: supporting the employment of Service spouses and partners; partnering with the <u>Forces Families Jobs Forum</u>; and providing flexibility in granting leave for Service spouses and partners before, during and after a partner's deployment.
   QPR solutions will be holding quarterly fundraising events to donate funds raised to the Walnut Tree Health & Wellbeing Charity.
- Reserves: supporting our employees who are members of the Reserve Forces; granting additional
  paid/unpaid leave for annual Reserve Forces training; supporting any mobilisations and deployment; actively encouraging members of staff to become Reservists; QPR Solutions Ltd would
  help support any staff member in the process as best possible in line with the current business
  needs.
- Cadet Organisations: supporting our employees who are volunteer leaders in military cadet organisations, granting additional leave to attend annual training camps and courses; actively encouraging members of staff to become volunteer leaders in cadet organisations; supporting local military cadet units; recognising the benefits of employing cadets/ex-cadets within the workforce.
