

JUDGMENT

- 1. The claimants' complaints against the second respondent are dismissed upon withdrawal.
- 2. The claimants' complaints pursuant to section 192 Trade Union and Labour Relations (Consolidation) Act 1992 ("TULRCA") against the first respondent are well founded.
- 3. The first respondent is ordered to pay to the claimants the sum identified in the schedule attached hereto by reference to the row in which their name appears and column headed "Balance Owed".
- 4. There is no order as to costs.

REASONS

- (1) This is a multiple claim against Aspray Transport Limited (in Administration) and The Secretary of State for Business, Energy and Industrial Strategy that was presented on 20 October 2020 following early conciliation between 18 and 23 September 2020.
- (2) It is made pursuant to s. 192 Trade Union and Labour Relations (Consolidation) Act 1992 ("TULRCA") namely the first respondent has failed, wholly or in part to pay a protective award.
- (3) It arises following an earlier decision of mine dated 10 June 2020 where I had understood the contents of which had been agreed and thus that was marked "consent judgment". The way I encapsulated that agreement was the subject of a subsequent dispute between the parties which was resolved by the Judgment being corrected on 18 July 2020. I am thus eager to ensure that any issue does not arise again.
- (4) On 10 November I directed the claim be listed for video hearing today (17 February 2021) before me, ordered the claimants to lodge amongst other matters a schedule of the sums claimed was lodged by the claimant's representatives and gave directions for trial. Those directions were subsequently varied.



- (5) A schedule (the Schedule) was subsequently lodged that was structured such that in the first few columns the title, fore- and sur-names of the various claimants were identified, in Column D, the claimant's gross weekly wage, Column E the protective award received by the claimant from the NI Fund, Column F the protective award the claimants respectively claim s/he was owed and Column G the balance of the sums claimed from the first respondent. Columns E, F & G are relayed in the Schedule below subject to the minor amendments I refer to below.
- (6) On 4 December 2020 an in time response was lodged by the second respondent indicating they were working with the other parties to hopefully resolve the claims without the need for judicial intervention but did not intend to appear at the final (merits) hearing.
- (7) No response was received from the first respondent and so I ordered a response not received notice be issued on 4 January 2021 against the first respondent.
- (8) The administrators of the first respondent helpfully confirmed by their email of 12 January that a judgment could be entered for the sums set out in the Schedule which was attached to the tribunal's email of 4 January 2021, and thereby for the avoidance of any doubt also gave consent.
- (9) By an email timed at 13:32 on Friday 12 February the claimant's representative lodged a slightly revised schedule to take into account payments received from the NI Fund and also adjusting in some cases, the headline sums claimed.
- (10) I identified the only apparent changes were that the sums sought against the first respondent had reduced as follows; Mr Davies (£-3,692.32), Mr Frain (£-3,153.84) and Mr Swann (£-2,342.87) and the payments from the NI Fund appeared to conclude the need for any involvement from the Secretary of State.
- (11) I instructed the Tribunal administrative staff to write to the parties on 15 February 2021 seeking that:-
 - "... all parties could confirm by return that it is agreed that :-
 - 1) a judgment may be entered against the first respondent only for the sums set out in column G of the revised schedule send by the claimants' representatives on 12 February 2021 (attached) and
 - 2) the claim against the second respondent can be dismissed on withdrawal.

I will in any event assume in the absence of receiving objections from the parties by 4.00pm tomorrow (16 February 2021) that that is so."

(12) At 16:15 on 15 February 2021 the Employment Tribunal received an email from the claimant's representative thus

"Further to our correspondence of 12.02.21 and the tribunal's correspondence of 15.02.21 we can confirm that the only changes to the spreadsheet were in respect of Davies, Frain and Swann for the sums set out in the tribunal's correspondence other than for Mr Swann which should read £2,790.40 rather than £2,342.87. These changes have changed the sums in column G accordingly."

(13) And the administrators at 16:58 the same day (15 February 2021) thus

"Please note that following a review of the amounts on the schedule provided for the new claims, against the Redundancy Payments Services' payments, there are two differences, noted below:

Carl Frain RPS payment £2,610.64 Schedule £3,153.84

Robert Swann RPS payment £2,592.64 Schedule £2,790.40"

(14) Neither addressed the confirmation that had been sought so I directed a response be sent as follows:-

"The parties are to **expressly confirm** as requested that

1) I may make the order I identified and

The claimant's representative to confirm that

- 2) given the sum sought in relation to Mr Swann is £1,695.17 that is a reduction of £2,342.87 <u>compared to the earlier schedule</u> in which the sum of £4,038.04 was sought (the difference quoted by Ms Toner arises from a difference in the Protective Award given £4,485.57 now sought which is higher and thus accounts for the difference) and
- 3) to clarify the position with the administrators given the administrators email of 15 February 2021 timed at 16:58 where there is no mention of Mr Davies in this.

If they cannot so confirm on all heads they will be expected to attend on Wednesday by CVP."


- (15) A substantive response was not received from any party. Notwithstanding given the current pandemic that is unhelpful given the disparity over the figures claimed and that I was eager to ensure there was no duplication of the issue concerning the consent judgment of 10 June 2020.
- (16) Ms Toner attended the hearing by the Cloud Video Platform today, the representatives of the other parties did not. I was advised by them both that they did not intend to do so.
- (17) Ms Toner confirmed that the claimants were agreeable to the claim against the second respondent being dismissed upon withdrawal and the sums claimed were correct as set out in the second schedule. She told me she had attempted to contact the administrators to address them making no mention of Mr Davies in their email of 16:58, 15 February 2021 but had not been able to contact them.
- (18) In the light of the administrator previously having agreed to a judgment for the sums claimed and those sums now being reduced by the sums received from the NI Fund in relation to the three claimants named above and in the absence of receiving specific objections sought from the parties by 4.00pm on 16 February 2021 I am satisfied the claimants were employees, the first respondent had not paid in full the protective award and the order sought could be made. I determined the s.192 complaint against the first respondent was well founded and an award be made for the sums set in the revised schedule.



(19) I agreed form of words in the form of the judgment set out above with Ms Toner and she also agreed the contents of the Schedule below were correct.


