Thank you for your email of 31 January in which you requested the following information:

"I am aware of the fact that Artificer training is accredited to higher level civilian qualifications which vary depending on stream. Could you please confirm the current qualifications, by level and title (eg BSc Electronics Systems Engineering; HND Automotive Engineering) for each of the Artificer courses shown below:

Artificer Electronics Artificer Vehicles Artificer Aircraft Artificer Avionics Artificer Weapons

In addition, would it be possible to provide me with the latest version of REME Corps Instruction E5, Artificer Selection and Training or direct me to where I can access this publication."

I am treating your correspondence as a request for information under the Freedom of Information Act (FOIA) 2000. A search for the information has now been completed within the Ministry of Defence, and I can confirm that the information in scope of your request is held and is below.

In response to your request please see below accreditation to higher level civilian qualifications for each of the Artificier courses:

Artificer Electronics – BSc in Electronic Systems Engineering via Portsmouth University Artificer Vehicles – Pearson Level 5 Automotive Engineering
Artificer Aircraft – Foundation Degree in Aviation Engineering via Portsmouth University Artificer Avionics – BSc in Electronic Systems Engineering via Portsmouth University Artificer Weapons – Pearson Level 5 Automotive Engineering

Under Section 16 (Advice and Assistance) you may find it useful to note that future accreditation of Artificier Vehicles and Artificer Weapons courses are currently under review and may change in the future.

In response to second part of your request, I can confirm that MOD holds information relating to your request. However, this information is exempt under Section 21 of the Act (reasonably accessible by other means). The requested information has been previously published and can be found in the link below:
