

WHEREAS by an Act passed in the Seventh Year of the  
 Reign of King George the Third, intituled *An Act for  
 erecting a proper and convenient Pier at the Port of Saint  
 Ives in the County of Cornwall, for the better Protection of Ships and  
 Vessels resorting to the said Port, the Justices of the Peace for the  
 County of Cornwall and for the Borough of Saint Ives for the Time  
 being were appointed Trustees for enlarging, improving, maintaining,  
 and preserving the said Port and Harbour of Saint Ives, by erecting,  
 and building a new Pier or Piers or other Works, and were autho-  
 rized to take certain Rates and Duties for or in respect of *British* and  
 Foreign Ships, Barges, and Vessels, and for Goods, Wares, and  
 Merchandise, and to raise any Sums of Money not exceeding Ten  
 thousand Pounds on Assignments of the said Rates and Duties, and  
 Grants of Life Annuities on the Credit thereof: And whereas the  
 Trustees acting in the Execution of the said Act have constructed a  
 Pier and other Works within the said Port and Harbour: And  
 whereas*

whereas no Mortgage or Annuity granted by the said Trustees now remains due or payable: And whereas the said Harbour might be greatly improved and rendered more commodious by the Construction of a new Pier and other Works: And whereas it is expedient that a Body of Commissioners should be constituted for the Purpose of constructing such new Pier and other Works, and for regulating and improving the said Harbour, and that the Works and Property of the said Trustees should be vested in such Commissioners: And whereas it is expedient that the said recited Act should be repealed, and that other Provisions should be made for the Regulation, Maintenance, and Improvement of the said Harbour: And whereas the Objects aforesaid cannot be effected without the Authority of Parliament: May it therefore please Your Majesty that it may be enacted; and be it enacted by the Queen's most Excellent Majesty, by and with the Advice and Consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the Authority of the same, as follows; (that is to say,)

Short Title.

I. That in citing this Act for any Purpose whatsoever it shall be sufficient to use the Expression "The Saint Ives Harbour Act, 1853."

Interpretation of this Act:

II. That in construing this Act the Words and Expressions following shall have the respective Meanings hereby assigned them, unless there be something in the Subject or Context repugnant to such Construction; (that is to say,)

Trustees:

The Expression "the Trustees" shall mean the Trustees acting in execution of the recited Act:

Commissioners:

The Expression "the Commissioners" shall mean the Commissioners acting in execution of this Act:

Old Works:

The Expression "the old Works" shall mean the Pier and Works made by the Trustees, and by this Act vested in the Commissioners:

New Works:

The Expression "the new Works" shall mean the Pier and Works by this Act authorized to be made:

Harbour.

The Expression "the Harbour" shall mean the Harbour of Saint Ives, as herein-after defined:

The Expression "Board of Trade" shall mean the Committee of Her Majesty's Privy Council for Trade and Foreign Plantations.

III. That "The Harbours, Docks, and Piers Clauses Act, 1847," (except such of the Provisions of that Act as are varied or excepted by this Act,) shall be incorporated with this Act: Provided always, that in construing that Act in connexion with this Act the Expression "the Special Act" in that Act shall mean this Act; and the Expression "the Harbour, Dock, or Pier" in that Act shall mean as well

well the new Works as also (until the same shall be removed under the Provisions of this Act) the old Works; and the Expression "the Harbour-master" in that Act shall mean, with reference to the Harbour, the Harbour-master, and with reference to the Piers, the Pier-master, continued in Office, or from Time to Time appointed by virtue of this Act.

IV. That the recited Act shall be and is hereby repealed.

V. That the Repeal of the recited Act shall not prejudice or affect any Purchase, Sale, Conveyance, Grant, Gift, Covenant, Contract, Act, Matter, or Thing whatsoever made, executed, or done by virtue or in pursuance thereof, but every such Purchase, Sale, Conveyance, Grant, Gift, Contract, Act, Matter, and Thing shall continue in full Force, and be as valid and effectual, to all Intents and Purposes, as if this Act had not been passed, the Commissioners being for all the Purposes thereof substituted for the Trustees.

VI. That the old Works, and all Buildings, Tenements, Rights, Privileges, Exemptions, Easements, Hereditaments, and Real Estate, and all Stocks, Funds, Monies, Tools, Implements, and Personal Estate and Effects whatsoever, which were vested in or belonging to the Trustees or any of them, or any Persons in trust for them, under the Powers or for the Purposes of the recited Act, immediately before the passing of this Act, or would have become vested in or have belonged to them if this Act had not been passed, and all the Estate, Right, Title, Interest, Property, Claim, and Demand of the Trustees in, to, upon, or over the same, and all their Rights and Remedies in respect thereof, shall, upon and after the passing of this Act, be and become in like Manner and Degree vested in and belong to and be available for the Commissioners; and all Persons in whom or in whose Names any such Real Estate, Stocks, Funds, and Personal Estate respectively were vested immediately before the passing of this Act, shall, when thereunto required by Writing signed by Two Commissioners, or by the Clerk of the Commissioners, convey, transfer, and assign such Estate, Stocks, and Funds respectively, according to the Nature and Quality thereof, to the Commissioners, or to such Persons as they shall appoint

VII. That all Debts and Liabilities of the Trustees shall be respectively paid, borne, and fulfilled by the Commissioners, the Commissioners being in reference thereto in all respects substituted for the Trustees.

VIII. That no Action, Suit, Prosecution, or other Proceeding shall abate or be discontinued or prejudicially affected by the Repeal of the said Actions not to abate.

XIII. That "The Lands Clauses Consolidation Act, 1845," and "The Commissioners Clauses Act, 1847," except the Section of the last-mentioned Act numbered 54, requiring daily Attendance at the Office of the Commissioners, and except such of the Provisions of those Acts as are varied or excepted by this Act, shall be incorporated with this Act.

XII. That all Byelaws made by the Trustees which shall be in force immediately before the passing of this Act shall, notwithstanding the Repeal of the recited Act, continue in full Force until repealed or varied under the Provisions of this Act.

Existing Byelaws to continue in force until altered.

XI. That all Officers and Servants of the Trustees acting in execution of the repealed Act shall, notwithstanding the Repeal of such Act, continue in the Discharge of their respective Offices and Duties, and be paid their accustomed Salaries and Wages by the Commissioners, and be Officers and Servants of the Commissioners, until they shall retire, or be removed or discharged by the Commissioners.

Officers to continue till removed.

X. That all Books and other Documents whatsoever which by the repealed Act were made Evidence or authorized to be given in Evidence shall, notwithstanding the Repeal of the said Act, be admitted as Evidence in all Courts of Law and Equity and elsewhere, as fully and effectually as the same would or might have been admitted as Evidence if the said Act had not been repealed.

Books, &c. to be Evidence.

IX. That nothing in this Act contained shall be held to prejudice or affect any Right or Cause of Action or Suit or any Remedy which the Trustees had against any Person, or which any Person had against the Trustees, at the Time of the passing of this Act, but all such Rights, Causes, and Remedies may be enforced or prosecuted by or against the Commissioners in like Manner and within the same Periods of Time as the same might have been enforced or prosecuted by or against the Trustees if this Act had not been passed.

Rights of Action saved.

said Act, and all Penalties incurred by or for any Offence against the Provisions of the repealed Act or any Byelaw of the Trustees may be recovered, and all Offences which may have been committed before the passing of this Act against the Provisions of the repealed Act or any such Byelaw may be prosecuted in such Manner, to all Intents and Purposes, as the same might have been sued for and prosecuted respectively if the said Act had not been hereby repealed, the Commissioners being with reference to all such Matters substituted for the Trustees.

XIV. That all Her Majesty's Justices of the Peace for the Time being in the Commission of the Peace for the Municipal Borough of Saint Ives aforesaid, and the Commissioners, and their Successors, to be appointed and qualified as herein-after mentioned, (and who are herein-after referred to as the Elective Commissioners,) shall be the Commissioners for executing this Act, and the said Justices shall be deemed Official Commissioners.

XV. That in naming or referring to the Commissioners under this Act for any Purpose whatsoever it shall be sufficient to use the Expression "The Saint Ives Harbour Commissioners."

XVI. That each of the Elective Commissioners shall have the following Qualification: He shall be resident within the Municipal Borough of Saint Ives aforesaid, and shall be either rated to some Rate made for the Relief of the Poor within the said Municipal Borough in the annual Sum of Twenty Pounds at the least, or be seized or possessed, in his own Right or in Right of his Wife, or partly in both Rights, of Real or Personal Estate, or of both Real and Personal Estate, of the Value of One thousand Pounds over and above what will satisfy his just Debts.

XVII. That the Number of the Elective Commissioners shall be Twelve, and that John Newnam Tynewarne, James Rosewall, Nathaniel Fyne, James Young, Moses Martin, Richard Kernick, Charles Newnam Tynewarne, Richard Stevens, Matthew Trewhella, William Christinas Jeacocke, Vivian Stevens Williams, and James Berrieman Williams, shall be the First Elective Commissioners.

XVIII. That the Elective Commissioners named in this Act shall go out of Office by Rotation in the following Manner; (that is to say,) on the First Monday in the Month of March in the Year One thousand eight hundred and fifty-five, One Third of those Commissioners shall go out of Office; and on the First Monday in the Month of March in the Year One thousand eight hundred and fifty-six, another Third of those Commissioners shall go out of Office; and on the First Monday in the Month of March in the Year One thousand eight hundred and fifty-seven, the Remainder of those Commissioners shall go out of Office; and in each Instance the Places of the retiring Commissioners shall be supplied by the Election of a like Number of Commissioners in the Manner herein and in "The Commissioners Clauses Act, 1847," provided.

XIX. That

The Saint Ives Harbour Act, 1853.

XIX. That every Burgess enrolled on the Burgess Roll for the Time being of the Borough of Saint Ives aforesaid shall be entitled to vote at every Election of Elective Commissioners under this Act.

Qualification of Electors.

XX. That the Meetings of the said Burgesses for the Election of Elective Commissioners shall be held at some Place in the Municipal Borough of Saint Ives aforesaid, to be from Time to Time appointed by the Commissioners, at Noon on the First Monday in the Month of March in the Year One thousand eight hundred and fifty-five, and at Noon on the same Day in every succeeding Year: Provided always, that the Commissioners may from Time to Time, if they think fit, vary the Hour and Place appointed by this Act, or by Order of the Commissioners, for Meetings for the Election of Commissioners.

Meetings for Election of Commissioners.

XXI. That the Commissioners shall hold their First Meeting at some convenient Place within the Municipal Borough of Saint Ives aforesaid, and shall hold their subsequent Meetings and adjourned Meetings at such Places within the said Municipal Borough as the Commissioners shall from Time to Time appoint.

Meetings of Commissioners.

XXII. That the annual Meetings of the Commissioners shall be held on the First Monday in the Month of February in each Year.

Annual Meetings.

XXIII. That the Commissioners shall require their Clerk, or some Person duly authorized by them in that Behalf, to attend at their Office at least Two Days in each Week, for the Purpose of receiving Notices, and transacting the ordinary Business of the Commissioners; and of Notice of the Situation of the Office of the Commissioners, and of the Days and Hours during which Attendance is given there, shall be published by the Commissioners within the Municipal Borough aforesaid in such Manner that the same may be fully and generally known.

Attendance at the Office of the Commissioners.

XXIV. That the Commissioners may borrow on Mortgage any Sums not exceeding in the whole the Sum of Twenty thousand Pounds; and if, after having borrowed any Part of the Money so authorized to be borrowed on Mortgage, the Commissioners pay off the same by any means except by the Application of the Sinking Fund herein-after mentioned, they may again borrow the Amount so paid off, and so from Time to Time.

Power to borrow.

XXV. That the Sum to be appropriated and set apart out of the Rates as a Sinking Fund to be applied in paying off the Principal Monies borrowed on Mortgages under the Powers of this Act shall be in each Year One Thirtieth Part of the Monies so borrowed; but it

it shall not be necessary for the Commissioners to appropriate and set apart any such sum or sinking fund until the expiration of Ten Years from the passing of this Act.

Appoint-ment of a Receiver.

XXVI. That the Mortgagees of the Commissioners may enforce the Payment of the Arrears of Principal or Interest due on any such Mortgage by the Appointment of a Receiver, provided that the Amount owing to the Mortgagees by whom the Application for a Receiver shall be made shall not be less than Five thousand Pounds in the whole.

XXVII. That inasmuch as a Plan and Section of the new

New Works.

Works, showing the Situation and Levels thereof respectively, and the Limits within which the same are intended to be constructed, and also a Book of Reference containing the Names of the Owners, Lessees, and Occupiers of the Land upon or through which the same are intended to be made, have been deposited with the Clerk of the Peace for the County of Cornwall: Therefore, subject to the Provisions in this Act and the said incorporated Acts contained, it shall be lawful for the Commissioners to make and maintain the Pier and new Works in the Situation and upon the Lands delineated upon the said Plan and described in the said Book of Reference, and according to the Levels defined on the said Section, and to make and maintain such Quays, Jettes, Floats, Stairs, Landing Places, Roads, Approaches, and other Works and Conveniences as they may think necessary for the Purposes of the said Harbour or the intended Pier, and to enter upon, take, and use such of the said Lands as shall be necessary for the Purposes aforesaid.

Limits of Deviation.

XXVIII. That in constructing the intended Pier and other new Works shown on the said Plan the Commissioners may deviate from the Lines thereof as laid down on the said Plan to the Extent of the Limits of Deviation defined on the said Plan.

Plan to be deposited with Admiralty before Works commenced.

XXIX. That, previously to commencing the intended Pier or Works connected therewith, the Commissioners shall deposit at the Admiralty Office Plans, Sections, and Working Drawings of the said intended Pier and Works connected therewith, and the intended Line and Site thereof, for the Approval of the Lord High Admiral of the United Kingdom of Great Britain and Ireland, or the Commissioners for executing the Office of Lord High Admiral aforesaid, such Approval to be signified in Writing under the Hand of the Secretary of the Admiralty; and such intended Pier and Works shall be constructed only in accordance with such Approval.

XXX. That

XXX. That the Powers of the Commissioners for the compulsory Purchase of Lands for the Purposes of this Act shall be exercised after the Expiration of Five Years from the passing of this Act.

Limit of compulsory Purchase

XXXI. That the intended Pier shall be completed within Seven Years from the passing of this Act, and on the Expiration of that Period the Powers by this Act and the Acts incorporated herewith given to the Commissioners with reference to the intended Pier shall cease to be exercised, except as to so much of the same Pier as shall then be completed.

Period for Completion of Works.

XXXII. That the Lands to be taken by the Commissioners for extraordinary Purposes shall not exceed Five Acres.

Lands for extraordinary Purposes.

XXXIII. That this Act shall be put in force for improving the Harbour of Saint Ives within the Space which would be enclosed between a straight Line drawn from the Easternmost Point of Saint Ives Head to the seaward End of Portsmouth Point, and the Line of High-water Mark between the said Points, and from Time to Time improve, cleanse, and deepen the said Harbour, in such Manner and to such Extent as they shall deem expedient.

Limits of Harbour.

XXXIV. That when the old Works shall have become vested in the Commissioners under the Provisions of this Act, the Commissioners may either maintain the old Works or any Part thereof, or if they shall think fit, may remove the same or any Part thereof, and sell or otherwise dispose of the Materials thereof, or may employ those Materials or any of them for the Purposes of the new Works: Provided always, that the now existing Pier shall not be removed until the Pier by this Act authorized to be made shall have been completed to the Extent of Four hundred Feet in Length.

Old Works may be maintained or removed.

XXXV. That if in the course or by means of the Execution of any of the said Works any Part of the Shores or Bed of the said Harbour, or of the Sea beyond the Mouth thereof, belonging to Her Majesty in right of Her Crown, shall be inned, gained, or reclaimed from the Water, the said Commissioners shall not have or exercise any Right upon the same or in respect thereof, but such Inning, Gaining, or Reclamation shall enure absolutely for the Benefit of Her Majesty the Queen, Her Heirs and Successors, and it shall not at any Time afterwards be lawful for the said Commissioners to take, enter upon, or interfere with the Land so inned, gained, or reclaimed, for any Purpose whatsoever, without the Consent in Writing of the Commissioners.

Any Land reclaimed by the Works not to be taken with- out the Con- sent of the Com- missi- oners of Woods, &c.

Commissioners for the Time being of Her Majesty's Woods, Forests, and Land Revenues, or One of them.

XXXVI. That every Person who shall dig, take, or remove any Ballast, Earth, Stone, or other Thing from or out of the Soil or Shore of the Harbour, without the Consent in Writing of the Commissioners of the Harbour, shall for every such Offence be liable to a Penalty not exceeding Five Pounds.

XXXVII. That if at any Time or Times it shall be deemed expedient by the Lord High Admiral of the United Kingdom, or the Lord High Admiral, for executing the Office of Lord High Admiral, to order a local Survey and Examination of the Pier or any Works of the Commissioners in, over, or affecting any tidal Water or navigable River, or of the intended Site thereof, the Commissioners shall defray the Costs of every such local Survey and Examination, and the Amount thereof shall be a Debt due to Her Majesty from the Commissioners, and if not paid upon Demand may be recovered as a Debt due to the Crown, with the Costs of Suit, or may be recovered, with Costs, as a Penalty is or may be recoverable from the Commissioners.

XXXVIII. That if any Pier or other Work to be constructed by the Commissioners in or across any tidal Water or navigable River, or if any Portion of the Pier or Work which affects any such Water or River or Access thereto, shall be abandoned, or suffered to fall into Disuse or Decay, it shall be lawful for the Lord High Admiral, or the Commissioners for executing the Office of Lord High Admiral, to abate and remove the same, or such Part or Parts thereof as he or they may at any Time or Times deem fit and proper, and to restore the Site thereof to its former Condition, at the Cost and Charge of the Commissioners, and the Amount thereof shall be a Debt due from the Commissioners to the Crown, and be recoverable accordingly, with Costs of Suit.

XXXIX. That the Commissioners may demand in respect of every Vessel entering or using the said Harbour within the Limits aforesaid Rates on Vessels. any Sums not exceeding the Rates mentioned in the Schedule (A.) to this Act, and every such Rate shall be payable by the Master of such Vessel.

XI. That the Owners or Masters of any Fishing Vessels not belonging to the Port of Saint Ives aforesaid may compound with the Commissioners for the Rates payable under this Act in respect of such Vessels, at the Sum of Ten Shillings for each Season of Six Months, [Local.] 23 X

XLVI. Provided always, That, except for the Use of their Warehouses, Cranes, and Weighing Machines, the Commissioners shall not take any Rate under the Powers of this Act until the said intended Pier shall have been completed to the Length of Four hundred Feet.

Limiting Period for commencement of Rates.

XLV. That the Commissioners may demand, for the Use of any of their Warehouses, Cranes, and Weighing Machines, of and from the Owner of any Goods deposited therein, or loaded, unloaded, or weighed by means thereof, such reasonable Rates as may be agreed upon between the Commissioners and such Owner.

Rates for Warehouses, &c.

XLIV. That so long as any Money shall remain due from the Commissioners on Mortgage or Bond it shall not be lawful for them to reduce the Rates for the Time being taken under the Powers of this Act, or any of those Rates, without the Consent of the Lords of the Committee of Her Majesty's Privy Council for Trade and Foreign Plantations in Writing for that Purpose first had and obtained.

While Debt existing, Rates not to be reduced without Consent of Board of Trade.

XLIII. That all Rates payable for or in respect of any Goods under the Provisions of this Act shall be paid by the Owner or Consignee of such Goods.

Owners to pay Rates on Goods.

XLII. That the Commissioners may demand, for all Goods mentioned or referred to in the Schedule (B.) to this Act, which shall be shipped or unshipped, received or delivered within the Limits of the Harbour, any Sums not exceeding the several Rates in the said Schedule (B.) specified with respect to such Goods.

Rates on Goods.

XLI. That the Commissioners may demand and receive, for all Pilchards caught by means of Boats using the Harbour, whether landed within the Harbour or not, and cured within the said Municipal Borough, Sixpence for every Hogshhead, and for all Pilchards caught by means of Boats using the Harbour, whether landed within the Harbour or not, but not cured within the said Municipal Borough, Sixpence for every Three thousand Fish.

Rates for Fish.

Months, such Seasons being respectively computed from the First Day of January to the Thirtieth Day of June, inclusive of both those Days, and from the First Day of July to the Thirty-first Day of December, inclusive of both the last-mentioned Days, and the Commissioners shall, when required, accept such Compositions: Provided always, that any such Compositions may be for a less Sum than Ten Shillings, if so agreed upon between the Commissioners and such Owners or Masters: Provided also, that all such Compositions shall be made at the same Rate per Ton on all such Fishing Vessels.

XLVII. That a Certificate under the Hand of the Chairman of Quarter Sessions shall be conclusive Evidence that the said intended Pier has been completed to the Length of Four hundred Feet, and such Chairman shall sign such Certificate, on Proof being adduced to him of such Completion.

XLVIII. That it shall be lawful for the Commissioners to lease the whole or any of the Rates payable by virtue of this Act for any Term not exceeding Three Years, upon such Terms, Covenants, and Conditions as the Commissioners shall think proper; and every Lessee shall have the same Powers, Rights, and Remedies for compounding and for recovering and enforcing the Payment of the Rates included in such Lease as are by this Act and the Acts incorporated herewith vested in the Commissioners for that Purpose.

XLIX. That all Monies which shall come to the Hands of the Commissioners under the Provisions of this Act shall be applied as follows; (that is to say,) Firstly, in paying the Expenses of obtaining and passing this Act, and preliminary and incidental thereto: Secondly, in paying to the Mayor, Aldermen, and Burgesses of the Borough of Saint Ives in the County of Cornwall the annual Sum of Twenty-five Pounds on the Second Day of February in every Year: Thirdly, in paying the Interest on all Monies borrowed for the Purposes of this Act, and for the Time being remaining unpaid: Fourthly, in setting apart the Sinking Fund (if any) for the Time being required under the Provisions of this Act for the Payment of all Principal Monies for the Time being due upon Mortgages granted by the Commissioners: Fifthly, in the Execution of the Works by this Act authorized: Lastly, in paying off all Principal Monies for the Time being due upon Mortgages granted by the Commissioners.

L. That the Powers of the Harbour-master for the Regulation of the Harbour may be exercised within the Limits of the Harbour as herein-before defined.

LI. That the Commissioners may appoint and license a sufficient Number of Persons to be Meters and Weighers within the Harbour or on the Piers.

LII. That the Payment of the said annual Sum of Twenty-five Pounds to the said Mayor, Aldermen, and Burgesses shall be in lieu and full Satisfaction of Quay Dues and Wharfrage, and all other Dues, Duties, and Payments now due or of Right payable to the said Mayor, Aldermen, and Burgesses, and all other Dues, Quay Dues, &c.

LIII. That if, upon Complaint made to the Board of Trade by any Person interested, in Writing under his Hand, it shall appear to the Board of Trade that there is reasonable Ground for believing that the Accounts of the Commissioners have not been duly kept, or that any Tolls, Rates, or Duties have been improperly or unfairly levied by them, or have not been applied in accordance with the Directions of this Act, the Board of Trade may appoint an Auditor to examine the Accounts of the Commissioners, and examine into the Matters so complained of, and to report to them thereon; and the Commissioners shall, upon Demand, produce to such Auditor all or any of their Accounts, Books, Deeds, Papers, Writings, and other Documents, and afford to him all reasonable Facilities for examining and comparing the same; and in case any Matter complained of shall be found to be true, the reasonable Expenses of such Auditor shall be paid by the Commissioners out of the Monies coming to their Hands under this Act, and may be recovered in any of the Superior Courts as a Debt due to the Crown.

Board of Trade may appoint an Auditor to examine Accounts.

LIV. That nothing in this Act contained shall extend to or affect the Places or Harbours called *Basset's Cove*, or *Portreech Harbour*, and *Hayle Harbour*, nor shall those Places or Harbours for the Purposes of this Act be deemed to be within or Part of the Harbour of *Saint Ives*.

LVI. That nothing contained in this Act or in the Acts herein

recited or referred to shall extend to authorize the Commissioners to purchase, take, use, or interfere with any Land, Soil, or Water, or any Rights in respect thereof, belonging to Her Majesty in right of the Duchy of Cornwall, without the Consent in Writing of Two or more of the principal Officers of the said Duchy, and which Consent such principal Officers or any Two of them are hereby authorized and empowered to give, or belonging to the Duke of Cornwall for the Time being, without the Consent of the said Duke, testified in Writing under the Privy Seal of the said Duke, first had and obtained for that Purpose, or to prejudice, diminish, alter, or take away any of the Rights, Profits, Powers, or Authorities vested in or enjoyed by Her Majesty, Her Heirs or Successors, in right of the Duchy of Cornwall, or in or by the Duke of Cornwall for the Time being.

LVII. That nothing whatsoever contained in this Act or in any of the Acts herein recited or referred to shall extend to divest, prejudice, diminish, alter, or take away any of the Estates, Rights, Privileges, Powers, or Authorities which now are or hereafter may be, or but for the Provisions of the same Act or Acts might have been, vested in or enjoyed by Her Majesty, Her Heirs or Successors.

LVIII. That nothing in this Act contained shall be deemed or taken to exempt the Harbour or the Commissioners from the Provisions of any General Act relating to Harbours or Dues on Shipping which may be passed during the present or any future Session of Parliament, or from any future Revision or Alteration, under the Authority of Parliament, of the Tolls, Rates, Dues, or Duties by this Act authorized.
