# Introduction

This latest set of Welsh Government Open Government commitments forms part of the overall UK Open Government National Action Plan 2019-21, along with commitments from the other devolved administrations.

The commitments outline our ambitions over the next two years to be more open and responsive to citizens, more accountable and to take a more collaborative approach to the way we work.

In developing this set of commitments, we have engaged with civil society and active citizens via the Open Government Network Wales, seeking to address some of the areas for more open working that they identified. We aim to continue and build upon this collaborative approach during the implementation of this current set of commitments and in developing future commitments.

# **Commitment 1: Engagement**

**We will investigate different ways of engaging with people and organisations in order to support greater collaboration and openness, including how to provide a more coherent, whole of Government holistic approach.**

## **Objective**

To involve and increase engagement and collaboration with a wider range of stakeholders.

## **Status quo**

The Well-being of Future Generations (Wales) Act 2015 places a duty on public bodies (including the Welsh Government) to take account of the importance of involving people with an interest in achieving the seven well-being goals set out in the Act and to ensure those people reflect the diversity of the population that they operate within.

The Welsh Government has a long-standing commitment to engagement, for example through the National Principles for Engagement, which it has endorsed. The Well-being of Future Generations Act has given renewed impetus to assess how the Welsh Government engages with and involves people in policy and decision - making.

We are engaging widely on our priorities and we continue to seek new and different ways of involving people and organisations. We have already made improvements to the way that we consult by developing an improved consultation service via gov.wales and we want to build upon this work.

## **Ambition**

To identify and develop different ways of engaging with people and organisations in order to gain a better understanding of the issues faced by citizens in Wales. The intended outcome is to ensure that citizens are involved in helping to develop policies that affect them and in the delivery of the services they may use.

# **Commitment 2: Access to Information**

**We will make information about how Welsh Government works easier to find and to access by making improvements to our website.**

## **Objective**

To help users find the information about Welsh Government and how it operates.

## **Status quo**

The Welsh Government website contains a substantial amount of information concerning the business of Government, how Government works and the relationship with the UK Government, Local Government and the National Assembly for Wales. Government business is wide ranging and the associated business processes can be complex.

Although information about Government business is hosted on the Welsh Government website(s), it is often dispersed, which can make it difficult for users to access the information that they require.

## **Ambition**

Improving accessibility to information that is held on gov.wales will enable people to gain a better understanding of the role of Welsh Government and how it works in relation to the UK and local government. This will also help people to identify where in Welsh Government responsibilities lie so that they can engage with the relevant department or an appropriate external body on issues of interest to them.

# **Commitment 3: Guidance on Open Data Publication for Public Bodies**

**We will work collaboratively to develop guidance that encourages greater publication and use of open data across the Welsh public sector.**

## **Objective**

To increase the amount of open data that is published by the Welsh public sector. The publication programme should have an emphasis on addressing the requirements of users, with an aim to encourage the greater use of open data.

## **Status quo**

Whilst there is interest in publishing open data in Wales, publication can be inhibited due to a lack of understanding of how to make data open and what data should be prioritised. This can result in information not being available or only being partially available, which can negate or limit its potential use by consumers.

By working collaboratively to develop guidance for the whole of the Welsh public sector, we envisage that more open data will be released, that there will be a consistent of approach to the releasing of open data and that the requirements of users will be addressed.

## **Ambition**

Through the increased use of published open data, a number of potential benefits could be realised, these include improvements in service delivery, increasing public engagement, greater accountability and the encouragement of economic activity.

# Commitment 4: Grants

**We are committed to making information about the grants and the grant application processes more openly available.**

## **Objective**

To provide greater clarity about the application and provision of Welsh Government grants.

## **Status quo**

Each year Welsh Government spends in the region of £13bn on grants across all Ministerial portfolio areas. Welsh Government routinely releases details of all payments made that are over £25,000 in value. An annual report on grants management is published, which presents a number of high - level grants statistics, however, there is no routine/regular publication of grant scheme or grant offer data.

By making grants data openly available, it is anticipated that the public will gain a better understanding about how Welsh Government spends money in Wales.

## **Ambition**

Making information available about how grants are issued will provide citizens with a better understanding of how public money in Wales is used and the activities that it funds. This will provide greater accountability. Providing clarity on what grants are available and how citizens can access them will ensure that everyone will have an opportunity to apply for the grants that they require.

# **Commitment 5: Legislation**

**We will help citizens understand the law applicable in Wales, by making information easier to find and by providing bilingual searching services and content.**

## **Objective**

To make Welsh law accessible, clear and straightforward to use.

## **Status quo**

For many years, concerns have been raised about the complexity of the law in the UK. This issue is particularly acute in Wales due to the devolution settlement, the single legal jurisdiction, difficulty in ascertaining where Acts of Parliament apply differently in Wales and the continued expansion of a bilingual body of distinct Welsh law. The Law Commission's 2016 report, "Form and Accessibility of the Law Applicable in Wales" considered the causes and impacts of inaccessible laws.

## **Ambition**

The long-term aim is to create a well-organised Welsh statute book that will categorise the law by Codes on specific subjects. We are also working towards improving how existing legislation (and its supporting documentation) is published and organised. This will include providing information about and demonstrating how the law in Wales is made.

# **Commitment 6: Financial Engagement**

**We will explore different ways of engaging with people and organisations to support a greater understanding, awareness and openness in relation to how the Welsh Government gets its funding, how money is raised through taxes devolved to Wales and how that funding is spent across devolved public services.**

## **Objective**

To raise awareness of Welsh Government finances, specifically about where the money comes from and how it is spent. Welsh Government is keen to engage with citizens to provide greater clarity and understanding about Welsh public finances.

## **Status quo**

Civil society wish to understand how Welsh Government determines budgets and how taxes are spent in Wales. They would like:

- to understand how Welsh Government decides where tax money is spent
- information about where tax money is spent
- assurances that Welsh Government is financially competent and spends money wisely.

## **Ambition**

To identify and develop different ways of engaging with citizens and organisations to increase understanding and participation in the journey between taxation and public spending in Wales.

To gain an understanding of citizen's priorities for Welsh Government spending and to help support decision-making about how those resources are used.

To develop more open processes and transparency around the budget process and Welsh Government spending.

To enable better access to the data that underpins the Welsh Government decisions to allocate resources in the most effective way.
