This is the “**Substantive Amendment Application**” which the Claimants indicated their intention to bring at the hearing of their “Extension Application” (app. Notice dated 10 December 2020) before Marcus Smith J on 14 January 2021.

2. Directions for service of the order, provided herewith, that is sought extending the injunction;
3. Permission to join and to re-amend their Claim Form and Particulars of Claim to join various “persons unknown” who the Claimants are now able to identify and name;
4. Retrospective orders for the alternative service of the Substantive Amendment Application; and

5. Further case management directions as appropriate.
