## **Authorized Amendment**

RA 3201 – Military Air Traffic Management. With the UK withdrawal from the EU, reference to EASA in relation to CAA Aviation Equivalence has been replaced by UK National Regulation.

RA 3203 – Controller Medical Requirements. Additional recognition of CAA medicals following the UK withdrawal from the EU.

RA 3293 – Surveillance Radar Approach. Figure 2 has been amended to reflect how the Thales TopSky display will show the range markers (removal of 'long size markers'); Figures 1 & 2 have also been renamed.

RA 3510 – Permanent Fixed Wing Aerodrome: Reference Information. Rewording and amended tables to align with ICAO documentation. This includes the understanding of aerodrome reference codes; this is particularly relevant when aerodrome improvement works take place and there is more than one Air System permanently based at a unit.

RA 3514 – Permanent Fixed Wing Aerodrome: Markings. Rewording and amended tables to align with ICAO documentation.
