Applications that fail to meet the eligibility criteria will be rejected. An email will be sent to the applicant detailing the reason(s) and indicating their right to appeal. Applications that meet the eligibility criteria will be loaded on a dedicated Huddle CS Facilitation Fund secure domain. Each Natural England Area team will have an identified lead to enable the assessment process and will arrange the local area assessment along with colleagues from the Environment Agency and Forestry Commission.

The second stage of the application process is an area appraisal, commentary and indicative score. This will also allow comments from area teams from Environment Agency, Forestry Commission and Natural England to support a score awarded.

This will be done by nominated officers in each of these three bodies who will also canvas local views. Natural England area team staff will liaise with relevant Environment Agency and Forestry Commission colleagues to agree a view on each application, award a score, and provide essential local information and sense checking of each application's viability and fit with Countryside Stewardship priorities for their area.

This stage of the assessment will need to be carried out and concluded between 15 - 30 November 2017
