Commencing on the road south-south-east of Nutgill Farm and proceeds generally north-east for approximately 89 metres, then turns and proceeds north for approximately 15 metres to north-west corner of building, then turns in a north-north-westerly direction for approximately 167 metres, then turns and proceeds in a generally north-easterly direction for approximately 64 metres, then proceeds in a generally north-easterly direction for approximately 62 metres, then proceeds in a generally northerly direction for approximately 288 metres to the junction with Langber End Lane.

As soon as possible after the deadline, the Secretary of State will send full copies to the Authority. Copies (excluding copies of any supporting documents - these will be available to view at the Authority's offices) will also be sent to the applicant, every person who has made an objection or representation and any other person who has written to us in respect of the Order.

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, Secretary of State will send a full copy to the Authority. Copies will also be sent to everyone who has made an objection or representation and any other person who has written to us in respect of the Order (excluding copies of any supporting documents - these will be available to view at the Authority's offices).

Within 14 weeks of the start date [by 15 June 2021]

Everyone who has made an objection or representation, the Authority, the applicant (if applicable) and anyone who has written to us in respect of the Order must ensure that their comments on any or every other statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of these comments to everyone else.


