The effect of the Order, if confirmed without modifications, will be to modify the definitive map and statement for the area by adding a Footpath in the Weymouth and Portland Borough:- From its junction with the eastern end of Verlands Road, south of Pickwick at SY 70728319, east along a compacted tarmac/stone/gravel surfaced path, passing to the north of 30 Verlands Road to SY 70738319 and continuing east along the path (via SY 70768319) to the field boundary at SY 70808320. Continue east, entering the field and across a grass surfaced path, running parallel with the southern fence line to the field boundary at SY 70928321. Turn east south east, down a hill (known as Winslow Hill) and across a field to its junction with Footpath 27 and the A353 Preston Road at SY 71128317. The width varies: 6.25 metres at SY 70728319, 7.8 metres at SY 70738319, 3.7 metres at SY 70768319, 3.6 metres at SY 70808320, 2 metres at SY 70928321, narrowing to 1.2 metres at SY 71128317. Limitation: Gate at SY 70928321.

As soon as possible after the deadline, the Secretary of State will send full copies to the Authority. Copies (excluding copies of any supporting documents - these will be available to view at the Authority's offices) will also be sent to the applicant, every person who has made an objection or representation and any other person who has written to us in respect of the Order.

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, Secretary of State will send a full copy to the Authority. Copies will also be sent to everyone who has made an objection or representation and any other person who has written to us in respect of the Order (excluding copies of any supporting documents - these will be available to view at the Authority's offices).

Within 14 weeks of the start date [by 13 July 2021]

Everyone who has made an objection or representation, the Authority, the applicant (if applicable) and anyone who has written to us in respect of the Order must ensure that their comments on any or every other statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of these comments to everyone else.

Any other person wishing to make representations in writing to the Secretary of State in respect of the above Order must do so in line with the timetable set out above.
