PROVISION OF REQUESTED INFORMATION

Thank you for your request for information about the importation of dogs which we received on 25 June 2020. Your request has been handled under the Freedom of Information Act 2000 (FOI).

The information you requested and our response is detailed below:

"Under the Freedom of Information Act 2000, I would like to make the following request:

• Since January 2020, how many transporters carrying dogs have been refused entry into the UK and then the animals being detained? - What is their origin?"

Between 01/01/20 and 26/06/20, the numbers of transporters carrying dogs which were detained and the transporter's country of origin is as follows:

Bulgaria	5

Latvia	3
Gibraltar	1
Hungary	5
Ireland	2

Poland	29

• "Since January 2019, how many dogs brought into the UK via the Dover port have been confirmed to carry the rabies virus?"

There have been no confirmed cases of rabies in the UK since January 2019.

• "What is the average length of time dogs spend in detention/quarantine?"

APHA is an Executive Agency of the Department for Environment, Food and Rural Affairs and also works on behalf of the Scottish Government, Welsh Government and Food Standards Agency to safeguard animal and plant health for the benefit of people, the environment and the economy.

The length of time dogs spend in quarantine after being imported from the EU can be anywhere from 24 hours (in the case of issues with tapeworm treatment) to 21 days (in the case of issues with rabies vaccinations).

• "Who makes the ultimate decision of dog imports into the Dover port UK, quarantine, release and investigation?"

This is the decision of the APHA Inspector with supporting evidence from a veterinary assessment for whether quarantine is required. Release from quarantine is the responsibility of the Veterinary Superintendent of the quarantine premises. The Local Authority may also carry our further investigation.

• "Who is the Veterinary Superintendent for Dover?"

There is no Veterinary Superintendent for Dover Port. A Veterinary Superintendent is aligned to a quarantine premises.

Information disclosed in response to this FOI request is releasable to the public. In keeping with the spirit and effect of the FOI and the government's Transparency Agenda, this letter and the information disclosed to you may be placed on GOV.UK, together with any related information that will provide a key to its wider context. No information identifying you will be placed on the GOV.UK website.
