J, the undersigned, certify that:-

The pigs were inspected within 24 hours prior to the scheduled departure to Great Britain and did not show any clinical signs of infectious or contagious disease and were fit to travel in accordance with Council Regulation (EC) 1/2005 (as amended).

The pigs are not animals to be destroyed under a programme to eradicate contagious or infectious disease.

- 3. The pigs did not originate from a holding or Assembly Centre in an area subject to any prohibitions or restrictions for reasons of animal diseases affecting porcine animals, in conformity with Community or national legislation.
- 4. The animals did not remain in the Assembly Centre for more than 6 days.*
- 5. A declaration has been received from the owner stating that the pigs to be exported have been resident on their holding of origin for the past 30 days, or since birth and no animal imported from a Third Country was introduced into the holding of origin during the 30 day period unless it was isolated from all other animals on the holding.
- 6. A declaration has been received from the owner/transporter stating that the pigs will be transported directly from Northern Ireland to the premises of destination.
- 7. A declaration has been received from the owner/transporter stating that after leaving the premises of origin, the pigs will be kept separate from animals of a lower/different health status or not similarly certified.
- 8. A declaration has been received from the owner/transporter stating that the vehicles used to transport the animals will be cleansed and disinfected with approved disinfectant prior to loading and after unloading, and before carriage of other animals.
- 9. A declaration has been received from the owner stating that the pigs have not been vaccinated against Aujeszky's Disease.
- 10. The pigs have remained separate since birth from wild cloven hoofed animals
