PROVISION OF REQUESTED INFORMATION

Thank you for your request for information dog seizures which we received on 22 June 2020. Your request has been handled under the Freedom of Information Act 2000 (FOI).

The information you requested and our response is detailed below:

"I am writing to request information regarding dogs seized and quarrentined when entering th UK,

I request as much information possible including dates (possibly by calander month but weekly or even daily woul be ideal) and reasons why the seizure took place. Information on the duration of each seizure also please."

Clarity was requested and was received the 26 June 2020.

"Regarding time period I would like data from the last 12 month period of available data possiblity up to the end of May 2020. Or if that is too recent the latest 12 month period of available data."

The definition of 'illegally landed' does not necessarily mean the animal was smuggled into Great Britain. Our definition of an illegal landing is any dog, cat or ferret that is landed in Great Britain which does not meet the import requirements and therefore requires quarantine under the Rabies Importation Order. While these figures may include some smuggled animals, it also includes:

- pet animals that arrive at UK airports and during the pets check are found to be non-compliant
- animals that are found 'inland' and after a trading standards investigation are found to be non-compliant

The information that we have provided is a true reflection of the information that we have access to. We can't guarantee the accuracy of this data, as we can only rely on the
