PROVISION OF REQUESTED INFORMATION

Thank you for your request for information regarding Omega Proteins Ltd, which we received on 24 June 2020. Your request has been handled under the Freedom of Information Act 2000 (FOI).

The information you requested and our response is detailed below:

"Is Omega Proteins Ltd, Wildriggs, Penrith, Cumbria, handling any category 3 animal waste, in particular fowl/meat from plants where coronavirus has been identified among workers? Is Omega licenced for category 3 animal waste rendering?"

The Animal and Plant Health Agency (APHA) acts as the competent authority and works to ensure compliance with the animal by-product (ABP) Regulations. APHA has a responsibility to provide advice and direction relating to the requirements of the ABP Regulations, how they are applied within the UK and APHA processes relating to approval and registration of ABP businesses. APHA carries out official controls and supervision of the handling of animal by-products and derived products to ensure compliance with the ABP Regulations. No additional information regarding an establishment outside the scope of those Regulations is maintained by APHA.

We can confirm that Omega Proteins is approved as a Category 3 processing plant as per the approved list available on GOV.uk (https://www.gov.uk/government/publications/animal-by-product-operating-plants-approved-premises).

Information disclosed in response to this FOI request is releasable to the public.
