### PROVISION OF REQUESTED INFORMATION

Thank you for your request for information regarding budgets and fraud prevention which we received on 1 July 2020. Your request has been handled under the Freedom of Information Act 2000 (FOI).

The information you requested and our response is detailed below:

"1. What is your organisations current staff headcount?

This information is exempt from release citing Section 21 of the Freedom of Information Act 2000 (FOIA) as it is already in the public domain and is reasonably accessible either as specific data or by manipulating the published data. 2. What was your organisations annual budget for the financial year 2019-2020?

The APHA budget gets re-stated in year so what the budget starts the year as is not necessarily what the budget is at the end of the year.

This information has been exempted from release citing Section 22a of the FOIA (information intended for future publication).

#### **Public Interest Test**

APHA recognise that there is a strong interest around the annual budget. However, we have concluded that the public interest in withholding the information sought outweighs the public interest in its disclosure. Releasing information now before it has been finalized would be misleading to the public on an already complex and sensitive issue

APHA is an Executive Agency of the Department for Environment, Food and Rural Affairs and also works on behalf of the Scottish Government, Welsh Government and Food Standards Agency to safeguard animal and plant health for the benefit of people, the environment and the economy.

and this would contradict the principles behind Freedom of Information. It is in the public interest to wait until the information has been collected and assessed rather than to release the information in a piecemeal fashion.

Given the importance of publishing only appropriately collated and checked figures, it is reasonable to expect that this information should be published in line with accepted practice rather than disclosed before official publication.
