PROVISION OF REQUESTED INFORMATION

Thank you for your request for information on illegal pet trade which we received on 16 July 2020. Your request has been handled under the Freedom of Information Act 2000 (FOI).

The information you requested and our response is detailed below:

"On illegal pet trade in the UK.

We did found a lot of very useful information on your website especially the Cats, Dogs and Ferrets Quarantine Licences 2013, 2014 and 2015 excel files but we would be very interested to know if we could access the data for 2016 to 2019.

We were also wondering if you do have record from more exotic species (such as reptiles for example) and they trade (legal and/or illegal) in the UK? It will be very interesting to investigate those as well. It look like there is data published for exotic animal import licences 2014 and other rabies susceptible mammals import licences 2014 but could we access data for several years? Do we know if those species have been legally or illegally imported in the UK?"

The Animal and Plant Health Agency (APHA) only holds records of illegally imported animals where the animal requires quarantine under the Rabies (Importation of Dogs, Cats and Other Mammals) Order. Please find data attached regarding all illegally imported animals quarantined under the Rabies Order between 2016 and 2019 at Appendix 1.

The definition of 'illegally landed' does not necessarily mean the animal was smuggled into Great Britain. Our definition of an illegal landing is any dog, cat or ferret that is landed in Great Britain which does not meet the import requirements and therefore requires quarantine under the Rabies Importation Order. While these figures may include some smuggled animals, it also includes:

APHA is an Executive Agency of the Department for Environment, Food and Rural Affairs and also works on behalf of the Scottish Government, Welsh Government and Food Standards Agency to safeguard animal and plant health for the benefit of people, the environment and the economy.

- pet animals that arrive at UK airports and during the pets check are found to be non-compliant
- animals that are found 'inland' and after a trading standards investigation are found to be non-compliant

Data on illegal imports outside of the Rabies Order are not held by APHA. This information would come under the remit of the individual Local Authority.

Information disclosed in response to this FOI request is releasable to the public. In keeping with the spirit and effect of the FOI and the government's Transparency Agenda, this letter and the information disclosed to you may be placed on GOV.UK, together with any related information that will provide a key to its wider context. No information identifying you will be placed on the GOV.UK website.
