In May 2019, the government announced it would return to referring to fixed period exclusion as 'suspension' and permanent exclusion as 'expulsion', to simplify terminology and prevent conflation.

We have heard the concerns raised by key stakeholders about the negative connotations of the term 'expulsion', and as a result we will refer instead to 'permanent exclusion' while continuing to use 'suspension' when referring to a fixed term exclusion.
