The Manual of Military Air System Certification (MMAC) comprises a collation of guidance material from within the MAA’s Regulatory Publications, Regulatory Notices and Defence Standard 00-970 pertaining to the Military Air System Certification Process (MACP). Accordingly, the MMAC represents an essential resource for the Regulated Community to support the MAA’s MACP for Military Air Systems.

This update to the MMAC provides additional guidance to the RC as follows: a new Glossary of Terms; guidance to complement the amendment to RA5820 regarding deleting the need for a Form 30 for Minor changes; iTCB guidance; clarification of Applicable vs Affected terminology; reinforcement of the need for TAAs to engage with the MAA early enough to influence the MAA Level of Involvement; reinforcement of the need to engage the MAA of changes which involve novel technology; and guidance on Security Cooperation Programmes.

In addition, MMAC Issue 2 replaces guidance previously contained in several MAA RN; consequently, the following RN are deleted concurrent with the publication of MMAC Issue 2:

- MAA/RN/2016/09 – Use of the European Military Airworthiness Certification Criteria (EMACC) [content of RN moved to MMAC Chapter 5 – Claiming Certification Credit within the MACP].
- MAA/RN/2016/12 – Military Type Certificates Explained and MAA/RN/2016/13 – The Approved Design Change Certificate Explained [content of both RNs moved to MMAC Chapter 4 – MTC and ADCC Explained].
