### Introductory note

#### This introductory note does not form a part of the notice.

The following notice gives notice of the surrender in part and variation of an environmental permit.

No waste activities, deposition or storage relating to the permitted waste activities under Environmental Permit ref. EPR/BU9068IM were carried out in the area of land to be surrendered. The Surrender Area is completely separated from the landfilled areas of the site. This is a low risk partial surrender application which does not require an intrusive site investigation. The risk that any pollution of this land could have occurred is therefore low and this conclusion is supported by the Site Condition Report.

A new reduced permit boundary is shown on drawing ref. P329 (located in Schedule 4).

Any changes made as a result of the part surrender are set out in the schedules.
