or products for export from the UK to Japan only]\* the imported poultry was confirmed free from any poultry infectious diseases as a consequence of import inspection conducted by the competent authority of the UK;

- [for imported raw material(poultry meat) only]\* the production facilities including the slaughtering, processing and storage facilities are authorised by the competent authority of the country of origin and the facilities are subject to periodical sanitary inspections conducted either by government veterinary inspectors or animal health inspectors appointed by the competent authority;
- g) [for imported raw material (poultry meat) only]\* the poultry used for the production of the meat as raw material for the poultry products to be exported from the UK to Japan were confirmed free from any poultry infectious diseases as a consequence of ante- and post-mortem inspections conducted by the inspector of the country of origin.
