# Monthly Summary

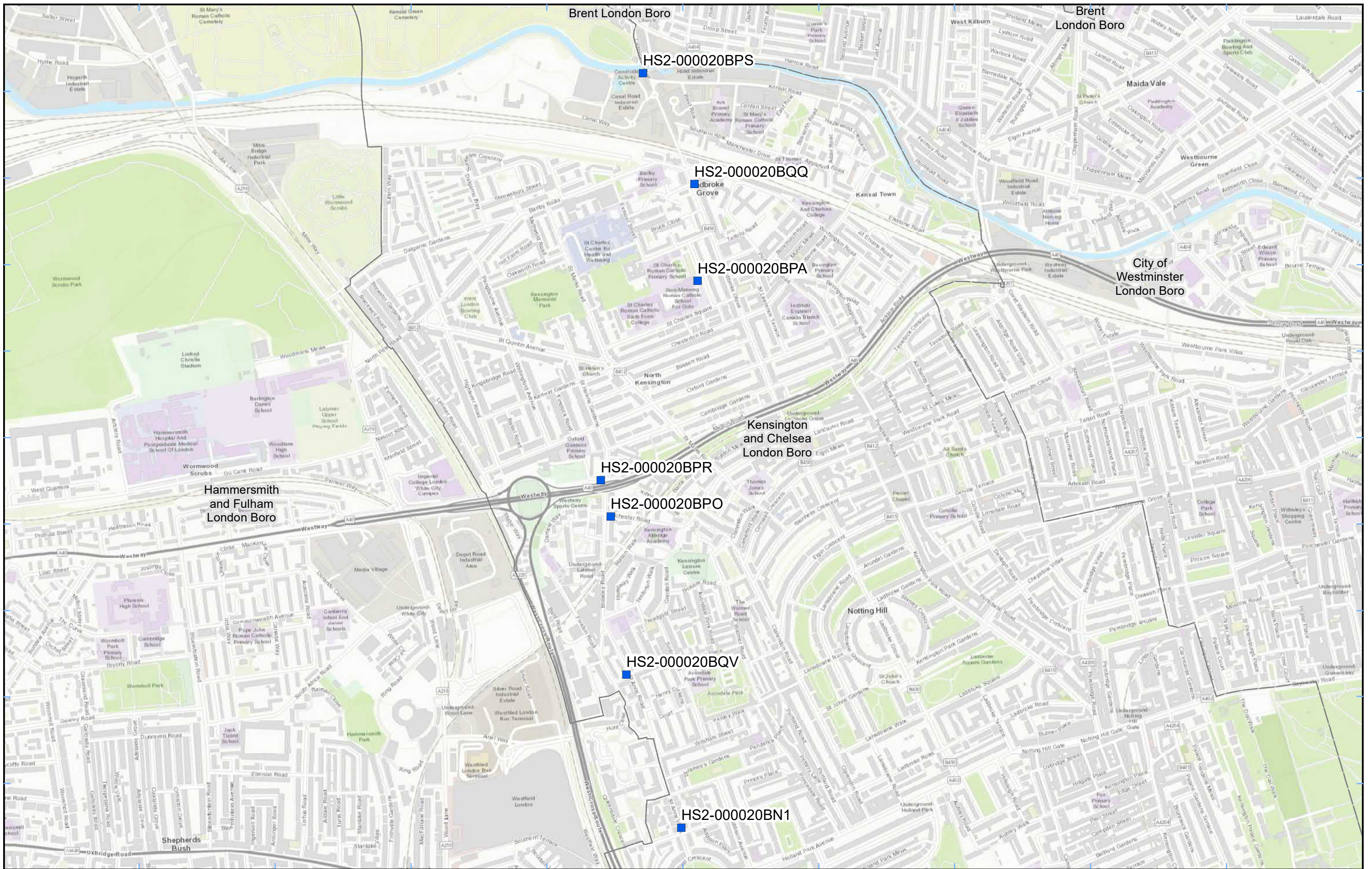
- 1.1.1 This Summary Report is published in fulfilment of commitments detailed in the High Speed Rail (London-West Midlands) Environmental Minimum Requirements, Annex 1: Code of Construction Practice, for the nominated undertaker to present the results of air quality monitoring undertaken in the Royal Borough of Kensington and Chelsea (RBKC) during March 2021.
- 1.1.2 Figure 1 in Appendix A presents the current air quality monitoring locations for April 2021.
- 1.1.3 This summary should be read in conjunction with the overview monitoring report available from [www.gov.uk/government/collections/monitoring-the-environmental-effects-of-hs2](http://www.gov.uk/government/collections/monitoring-the-environmental-effects-of-hs2), which highlights: the applicable standards and guidance, as well as the air quality and dust monitoring methodologies to be implemented by nominated undertakers throughout construction.
- 1.1.4 There are no current worksites located within the RBKC. Therefore, no dust monitoring has been carried out.
- 1.1.5 Diffusion tube monitoring of Nitrogen Dioxide (NO<sub>2</sub>) is undertaken at seven (7) locations in around highways within the RBKC as part of the management of air quality where significant effects may occur as a result of the scheme. However, based on the results to date, no unexpected values were recorded during the monitoring period.
- 1.1.6 Diffusion tube monitoring results are provided from the laboratory analysis, and therefore still require various analysis and adjustments to be undertaken. Final corrected results will be presented and described in the annual report.
- 1.1.7 NO<sub>2</sub> monitoring locations and results are presented in Appendix B, Table 1, together with the 2021 running mean.
- 1.1.8 There were no (0) complaints received, relating to air quality, during this reporting period (April 2021).
