#### Freedom of Information Act 2000: request for an internal review

You wrote to us on 22 May 2021 asking us to review our response of 20 May to your Freedom of Information request for communications between Tom Scholar and David Cameron about Greensill Capital.

Your request for an internal review was made as follows:

I would like to appeal against your verdict that you're unable to respond to much of my request in the referenced Freedom of Information request. In your response, you state:

"Your other requests relate to responses from Mr Scholar to Mr Cameron's text messages between 5 March and 7 April 2020. The Treasury does not hold this information. On 1 June 2020, Mr Scholar's mobile phone had to be reset, after being automatically locked when an incorrect password was entered several times (this is a standard security feature on Treasury mobile phones)."

While I accept that this means you are unable to retrieve Mr. Scholar's texts from his own phone, it seems extremely likely that a record of these messages will still exist on Mr. Cameron's phone, not least because he has himself released the text of his messages to Mr. Scholar.

I accept that the HM Treasury Information unit has no powers to compel Mr. Cameron to release these, but it strikes me that it would be well within your remit to instruct Mr. Scholar to make the request of Mr. Cameron to provide the requested information from his own telephone. He has already released his own messages, and would no doubt accede to a request from Mr. Scholar to release Mr. Scholar's messages. These could then be redacted as necessary by the Information Unit and released in accordance with my FOI request.

We can confirm that we now hold further information within the scope of your request. Mr Scholar's text messages to Mr Cameron were provided to us by Mr Cameron's office, having been requested by us in accordance with an undertaking made by Mr Scholar to the Treasury Select Committee at an oral hearing on 27 May 2020. In the light of the public interest in this exchange we are including in our release personal information outside the scope of the Freedom of Information Act.

We are also withholding personal contact details under **section 40(2)** of the FOI Act which, by virtue of section 40(3A)(a), provides an absolute exemption for third party personal data, where disclosure would contravene any of the data protection principles set out in Article 5 of the UK General Data Protection Regulation.
