# JUDGMENT

1. The claimant's claim of indirect age discrimination and discrimination contrary to the Fixed Term Employees (Prevention of Less Favourable Treatment) Regulations 2002 are dismissed on withdrawal by the claimant.
2. The claimant's claim of unfair dismissal and discrimination contrary to the Part Time Workers (Prevention of Less Favourable Treatment) Regulations 2000 are well-founded and succeed.
3. The respondent is ordered to pay to the claimant compensation as follows:
  - (1) A basic award in the amount of £1,650; and
  - (2) A compensatory award in the amount of £4,448 comprising compensation for loss of statutory rights in the amount of £350 and compensation for loss of income for eight weeks in the amount of £4,098.

4. The figures provided are based upon an agreement between the parties regarding the amount of a week's pay for the claimant.

### THE EMPLOYMENT TRIBUNALS (INTEREST) ORDER 1990

The Employment Tribunals (Interest) Order 1990 provides that sums of money payable as a result of a judgment of an Employment Tribunal (excluding sums representing costs or expenses), shall carry interest where the full amount is not paid within 14 days after the day that the document containing the tribunal's written judgment is recorded as having been sent to parties.
