Summary Description of Project / Proposed development

This declaration refers to a report produced by AECOM on Stage 2 of the soil investigation into potential land contamination caused by the Grenfell Tower fire. The work was undertaken during the period May 2020 to March 2021, with the sampling of soil and crops taking place in October to November 2020. The investigation has been carried out under Part 2A of the Environmental Protection Act 1990 and in accordance with the statutory guidance for Part 2A, and has been subject to review by the Multi-Agency Partnership, Scientific Advisory Group, and me as the independent Suitably Qualified Person.

The objectives of the investigation were to determine the geographical extent of any significant contamination caused by the fire; establish whether there are unacceptable risks to human health; provide recommendations in relation to the Part 2A classification of all potential significant contaminant linkages; and provide recommendations for whether or not any land appears to meet the definition of contaminated land, under Part 2A. Stage 2 followed on from the Stage 1 investigation, which was reported in 2019 and subject to a separate SQP declaration under the NQMS (See below). I was able to observe parts of the site walkover and soil sampling and also reviewed and commented on earlier drafts of the report.
