The data will allow the identification of students in receipt of different elements of the education recovery package:

Repeat Year

For the repeat year it will inform the level of funding at an individual institution as a cap will be applied for the percentage of students eligible to be funded.

16-19 Tuition Fund

For the 16-19 tuition fund – it will identify students in receipt of the tuition fund contributing to the accountability measures required as part of the conditions from HMT for the fund.

School led tutoring

For the school led tutoring – it will identify pupils in receipt of tutoring and in later censuses, the number of hours they are receiving. This will contribute to the accountability measures required as by HMT

Impact of not doing the change

The data is important to help us understand the pupils that are in receipt of these elements, ensuring that we can target funding at those pupils that need support most.

It will allow us to understand impact on attainment in future years and build evidence to make sure that schools can be provided with more funding of this nature to support to a very specific and needy cohort.
