Thank you for your recent email, which was processed under the Freedom of Information Act 2000 (FOIA). You requested the following information:

HIF funding Cambridge Waste Water Treatment Plant Relocation

The CWWTP relocation is driven by the North East Cambridge Area Action Plan to deliver 5600 dwellings and associated retail and commercial building on the current site at Cowley Road Cambridge. The grant of £227 million was agreed to enable the relocation of the WWTP.

Please tell me if there were any conditions on timescale of house building placed with Cambridge City Council and Greater Cambridge Shared Planning on this grant (20 years seems a long time).

Response

We are able to confirm that Homes England does not hold the information detailed in your request. This is because there is no business reason for Homes England to do so.

In order to conclude that the information is not held, we have searched with our Project team who would have the requested information if held.

The FOIA does not oblige a public authority to create information to answer a request if the requested information is not held. The duty under section 1(1) is only to provide the recorded information held.
