CORRECTED JUDGMENT BY CONSENT

- The Tribunal finds that there should be a protective award paid limited to the Claimants (listed in the attached schedule) who are members of the Claimant trade union, who were employed by the Respondent as Warehouse Operatives or Warehouse Supervisors based at the Greenwich branch.
- 2. The award shall be in respect of the protected period which begins before or after the date of the Claimants' dismissal, for a period of 59 days.
- 3. The Claimant is to be paid remuneration for the period of 59 days pursuant to section 190 of the Trade Union and Labour Relations (Consolidation) Act 1992.
- 4. There should be no order as to costs.
- 5. The Claimants were dismissed as redundant on or after 14th May 2020 and the protected period of 59 days begins on 14th May 2020. The parties agree the end dates were as follows:
