Daptomycin 350 mg and 500 mg Powder for Solution for Injection/Infusion (Daptomycin): Interim Supply of German Stock to Mitigate Supply Disruption

Dear Healthcare Professional,

Summary: Dr. Reddy's is currently experiencing supply disruption with Daptomycin 350 mg and 500 mg Powder for Solution for Injection/Infusion in the UK.

To ensure continuity in supply, Dr. Reddy's has obtained approval from the Medicines and Healthcare products Regulatory Agency (MHRA) to supply German product (batch number K210131 (350 mg) and K210073 (500 mg); 960 packs per batch), which has been repackaged in UK livery and is expected to be on the UK market from 20/07/2021 and 01/08/2021 respectively.

Please note the following:

- This product is considered licensed in the UK.
- The product from Germany has the same formulation as the UK product
- The product from Germany is manufactured according to the same manufacturing process and quality controls as the UK product.
- There are no differences between product information of the repackaged German product and the UK product.
- The UK product information will be supplied with the product.

- The MHRA has approved this product under a batch specific variation to the marketing authorisation.

Please ensure all relevant staff are made aware of the content of this letter and that the information is communicated to the patients.
