#### AMENDED JUDGMENT BY CONSENT

UPON reading the joint application submitted by or on behalf of;

- 1. The claimants named in Schedule 1 ("the Claimants");
- 2. Simons Construction Limited (in administration); and
- 3. Simons Group Limited (in administration)

**AND UPON** those parties having agreed to the terms of the Judgment set out below by consent, the Judgment of the Employment Tribunal made under Rule 64 of Schedule 1 of the Employment Tribunals (Constitution & Rules of Procedure) Regulations 2013 is that:

#### **Correct Respondent**

- 1. The Claimants were employed by the respondent indicated in the table in Schedule 1.
- 2. All claims presented by the Claimants in Schedule 1 against any other respondent is dismissed on withdrawal save for the Third Respondent.

#### **Protective award**

- 3. In relation to the Claimants named in the attached Schedule 2 to this Judgment;
- 3.1 Simons Construction Limited (in administration) failed to adequately comply with a requirement of section 188 of the Trade Union & Labour Relations (Consolidation) Act 1992 and the claim for a protective award brought under section 189 of the Trade Union & Labour Relations (Consolidation) Act 1992 succeeds.
- 3.2 Simons Construction Limited (in administration) is ordered to pay remuneration (i.e. a protective award) to the Claimants named in Schedule 2 for a protected period of 90 days beginning on 31 October 2019 (being the date on which the first of the dismissals to which the complaint relates took effect).

- 4. In relation to the Claimants named in the attached Schedule 3 to this Judgment;
- 4.1 Simons Group Limited (in administration) failed to adequately comply with a requirement of section 188 of the Trade Union & Labour Relations (Consolidation) Act 1992 and the claim for a protective award brought under section 189 of the Trade Union & Labour Relations (Consolidation) Act 1992 succeeds.
- 4.2 Simons Group Limited (in administration) is ordered to pay remuneration (i.e. a protective award) to the Claimants named in Schedule 3 for a protected period of 90 days beginning on 31 October 2019 (being the date on which the first of the dismissals to which the complaint relates took effect).
- 5. The claims for a protective award brought by the Claimants named in Schedule 4 remain live and shall proceed to be heard at the full hearing commencing on 28 June 2021.

#### Other claims

6. All other claims brought by the claimants named in Schedule 1 against the respondents remain stayed.

#### Costs

7. There is no order requiring any party to pay or reimburse another party's costs or fees in relation to the claims referred to in Schedules 2 and 3 and each party shall bear their own costs and fees in relation to those claims.
