Converter Academy Orders

Points discussed in relation to school conversion.

Project: Blidworth Oaks Primary School, Nottinghamshire, to join East Midlands Education Trust

AB discussion:

Ofsted good June 2017 (short inspection).

The school considered a number of trusts, however they were of the opinion that East Midlands Education Trust was the most suitable match due to sharing the same ethos and values of the school and the community it serves.

The trust is well-established and the school believes that it would benefit from the support available from other schools within the trust.

The financial health of the school, the strength of financial management and governance at the East Midlands Education Trust and the impact on the trust's future financial health if this school joins were considered.

Project: Heathlands Primary School, Nottinghamshire, to join East Midlands Education Trust

The school considered a number of trusts, however they were of the opinion that East Midlands Education Trust was the most suitable match, due to an existing positive working relationship and sharing the same ethos and values.

The governors, parents and staff are all supportive of the school joining the trust.

The trust is well-established and the school believes that it would benefit from the support available from other schools within the trust.

The school is working in a successful collaboration with Blidworth Oaks, a primary school which has also requested to join the trust.

The financial health of the school, the strength of financial management and governance at the East Midlands Education Trust and the impact on the trust's future financial health if this school joins were considered.

Free School Presumption – Sponsor Approval

Points discussed in relation to a free school's sponsor status.

Project: Castle Donington Primary Free School, Leicestershire, discussion to consider sponsor options.

AB discussion:

Leicestershire County Council are proposing to establish a 210 place primary school. This is to meet the demand for primary places arising in the area due to inward migration to the catchment area, new housing development and increased birth rates.

Schools in the area have limited or no spare capacity. Provision is to cater for pupils aged 4 to 11 years old.

It is envisaged that the school will open with Reception year only and grow incrementally over the next seven years, in order to avoid having an adverse impact on other primary schools in the locality.

As a presumption free school, the local authority will provide funding to cover the cost of opening the proposed new school and Section 106 funding has been secured in respect of the Charters Gate housing development currently being built on land to the west of Castle Donington.

The school is proposing to open in September 2022. The local authority's preferred sponsor is Scholars Academy Trust. The trust has capacity to establish new schools on the basis of high expectations and high performance as well a strong desire to work closely with other education providers in the locality. The trust has a proven track record of school improvement.

The strength of financial management and governance at Scholars Academy Trust and the impact on the trust's future financial health if the proposal goes ahead were considered.

The proposal is a voluntary transfer.

The college recognises that it would benefit from being part of a larger organisation, with a central trust team and where school improvement support can be provided.

Castle Donington College has an existing working relationship with the trust and has been collaborating on various projects.

The board considered the transfer to be a good strategic move, which will drive further improvement in learning and teaching.

The high-quality leadership at the college could add capacity to the trust to enable it to assist other schools.

The financial health of both trusts; strength of financial management and governance at East Midlands Education Trust, and the impact on the trust's future financial health if this transfer goes ahead were considered.
