Thank you for your request for information which was processed in accordance with the Freedom of Information Act 2000 (FOIA).

You requested the following information:

I am making enquiries with regard to the former Royal Manor Arts College, Weston Road, Portland. Dorset. DT5 2RS.

The property was acquired for the developement of housing many years back. Since then the trees, shrubs and weeds planted within the campus have never been pruned, cut back, removed or cleared. As such they are, now, spilling over onto the surrounding pathways and roads. The rubbish in them (including rotting meat, vegetables etc and human detrius) is giving off noxious odours not very pleasent for those who live nearby. Strangely enough, the majority of the grass has been mown on a regular basis.

Could you, please let me know; Who is responsible for this work? When, if ever, the developement will go ahead? Who is footing the bill for the security? How much has the Security cost so far?

Lastly, will you give me details as to how I can contact the Housing Minister.

Response

We can confirm that we do hold some of the requested information. We will therefore address each of your question in turn.

Who is responsible for this work?

We can confirm that Homes England are responsible for the Estate Management of this site.

When, if ever, the development will go ahead?

We can confirm that Homes England does not hold the information detailed in your request.

To comply with this duty, we are able to confirm that Homes England have secured outline planning consent for a residential scheme and are still in the process of appointing a development partner. The development partner will then need to secure reserved matters planning consent before development of the site can commence. The planning application and other documentation are/will be available to view on the Council's planning portal via the following link using reference WP/19/00919/OUT: Planning application search - dorsetforyou.com (dorsetcouncil.gov.uk).

Who is footing the bill for the security?

We can confirm that Homes England are responsible for the security of the site.

How much has the Security cost so far?

We can confirm that, to date, the security cost from April 2018 is circa £600,000.
