Thank you for your request for about dog imports, which we received on 08 January 2021. Your request has been handled under the Freedom of Information Act 2000 (FOIA).

The information you requested and our response is detailed below:

Please note 2015 data is no longer available from the TRACES system.

The information that we have provided is a true reflection of the information that we have access to. We can't guarantee the accuracy of this data, as we can only rely on the information that has been input into TRACES by a third party.

TRACES (Trade Control and Expert System) is a European Commission system employed by EU member states to facilitate and record animal/animal product movements into and throughout the EU. This data was extracted from TRACES.

APHA is an Executive Agency of the Department for Environment, Food and Rural Affairs and also works on behalf of the Scottish Government, Welsh Government and Food Standards Agency to safeguard animal and plant health for the benefit of people, the environment and the economy.

The data for commercial dog imports was extracted from TRACES through the data warehouse facility by searching for imports of canis familiaris. These figures cover all commercially imported dogs including commercial puppies, rescue dogs, research dogs and unaccompanied pets.
