### **PROVISION OF REQUESTED INFORMATION**

Thank you for your request for information about dog import statistics which we received on 15 January 2021. Your request has been handled under the Freedom of Information Act 2000 (FOI)

The information you requested and our response is detailed below:

"Under the Freedom of Information Act 2000 I seek the following information on illegally landed animals:

1. The number of 'illegally landed' animals imported into Great Britain. I would like this information broken down by type of animal e.g. dogs, cats etc.

I would like this information for January 2019 to December 2020, broken down by month i.e. January 2019, February 2019 etc.

If it is not possible to provide a monthly breakdown, I would like this information for the last two years, broken down by year i.e. 2019 and 2020."

**Please note:** The definition of 'illegally landed' does not necessarily mean the animal was smuggled into Great Britain. Animal and Plant Health Agency's (APHA) definition of an illegal landing is any dog, cat or ferret that is landed in Great Britain which does not meet the import requirements and therefore requires quarantine under the Rabies Importation Order. While these figures may include some smuggled animals, it also includes:

- pet animals that arrive at UK airports and during the pets check are found to be non-compliant
- animals that are found 'inland' and after a trading standards investigation are found to be non-compliant
