## **PROVISION OF REQUESTED INFORMATION**

Thank you for your request for information about seed packets, which we received on 02 February 2021. Your request has been handled under the Freedom of Information Act 2000 (FOIA).

The information you requested and our response is detailed below:

"I write under the Freedom of Information act to request information relating to an investigation carried out by APHA last August, into seed packages sent unsolicited to Brits. Most of these packages appeared at the time to have come from China and were often marked as earrings, beads or other non-plant items.

Specifically, I would like to know:

"1.How many reports APHA received of such packages?"

APHA have received in the region of 3000 queries which we can attribute to unsolicited seed.

"2. How many of these were collected by APHA for sampling and testing?"

When APHA received a query we requested the enquirer to send the seed to APHA – approximately 1800 packages received which had between 1 - 10 packets of seed.

"3.Whether an investigation was carried out? If so, please provide a copy of any investigation documents."

We are conducting both scientific work (physical and molecular identification of the seed received) and also a documentary investigation based on the information received from

external stakeholders (private individuals, companies, etc) to determine which online sites and suppliers can be linked to the unsolicited seed.

As this investigation is continuing and pending publication, it is exempt from release under Section 22a of the FOIA. The use of this exemption is subject to a Public Interest Test. Please see below for further information.

"4.Whether any advice (eg, on customs and security) was issued as a result of the case? If so, I would like a copy of any guidance or advice produced."

Ongoing work with customs who are working alongside APHA at various UK points of entry to identify mail/packages that may contain unsolicited seed.

The public through various means have been asked not to plant any unsolicited seeds they have received, but to destroy them, or send them into APHA for destruction and further investigation. Please see advice here:

Section 22a – Public Interest Test

APHA recognise that there is a strong interest around unsolicited seed parcels. However, we have concluded that the public interest in withholding the information sought outweighs the public interest in its disclosure. Releasing information now before it has been finalised would be misleading to the public on an already complex and sensitive issue and this would contradict the principles behind Freedom of Information. It is in the public interest to wait until the information has been collected and assessed rather than to release the information in a piecemeal fashion.

Given the importance of publishing only appropriately collated and checked information, it is reasonable to expect that this information should be published in line with accepted practice rather than disclosed before official publication.

Information disclosed in response to this FOI request is releasable to the public. In keeping with the spirit and effect of the FOI and the government's Transparency Agenda, this letter and the information disclosed to you may be placed on GOV.UK, together with any related information that will provide a key to its wider context. No information identifying you will be placed on the GOV.UK website.

An Annex is attached which explains the copyright that applies to the information being released to you and contact details should you be unhappy with the service you have received.
