## SPLI – Quarterly Update – Final Report – 16 Nov 20.

## Introduction

1. This is the last quarterly report of Service Police Legacy Investigations (SPLI). It covers the period from 30 Sep 20 to 16 Nov 20. In this quarter, SPLI has closed, or is in the process of closing, 1 full investigation. The SPLI caseload is complete.

## Caseload

- 2. Since SPLI took on the remaining legacy cases, on 1 Jul 17, it has closed, or is in the process of closing, 1291 allegations.

## Referrals

- 3. SPLI inherited one referral from IHAT to the Service Prosecuting Authority (SPA). It has since been discontinued by the SPA.
- 3.1. In April 19, the Service Police referred three individuals to the Service Prosecuting Authority (SPA) in relation to two separate incidents, in which two Iraqi citizens died in the custody of UK armed forces in 2003. In July 19, the SPA decided that no charges should be directed in this case.
- 3.2 At the end of September 19, the Service Police referred two individuals to a nominated Commanding Officer (CO) in relation to offences linked to alleged assaults and abuse of Iraqis held by UK armed forces in April 2004. In October 19, the CO referred the individuals to the SPA. The SPA decided no charges should be directed in this case.
