PROVISION OF REQUESTED INFORMATION

Thank you for your request for information about Export Health certificates, which was passed to APHA as the agency most likely to hold this information by Defra and received on 23 March 2021. Your request has been handled under the Freedom of Information Act 2000 (FOI).

The information you requested and our response is detailed below:

"What will be the estimated monthly total number of export health certificates (EHCs) required for export to GB to the EU after the 21 April 2021 extension to include export composite products containing products of animal origin (POAO) as an ingredient?

Please specify if this is including GB to NI figures

What is the annual estimated cost of these Export Health Certificates (EHCs) to UK businesses?

What is the estimated number of Official Veterinarians (OVs) that will be required to certify these EHCs?"

The Animal and Plant Health Agency (APHA) do not hold this information.

"On what evidence do you base your required number of OVs?"

Certain composite products that do not currently need an Export Health Certificate (EHC) will require an EHC document when exported to the EU. However, so long as composite products are shelf stable and do not include meat, and are in line with other EU heat treatment requirements they will only require a private attestation signed by the EU importer, rather than a EHC document.

On products that already require an Export Health Certificate at the moment, the current EHC can be used until August 2021. From 21 April, there will be two new EHCs and one

new model document that need to be applied for composite products. There will also be three new EHCs for other Products of Animal Origin (POAO).

A range of products that require a private attestation to move to the EU, including certain chocolates, pastas, breads, cakes and biscuits will not be required to undergo checks at an EU Border Control Post. The private attestation will only be required at the point they are placed on the market.

The requirements for individual products – whether that be an EHC or private attestation will depend on the ingredients included and the process by which they are made. We will be providing a 'information to traders to help them assess what is required for their own individual products.

To help ensure any disruption after Brexit is kept to a minimum, we have tripled the number of Official Veterinarians qualified to sign EHCs for animal products since 2019. We also funded surge capacity veterinarians as short-term support if it was required, but thus far demand for this service has been low. We will continue to assess certifier capacity and emerging issues via our regular calls with industry.

On 1 October 2020, Defra relaunched funded training to increase the number of OVs able to certify POAO (including fish) and certain live animals. The number of Official Veterinarians qualified to sign EHCs for animal products has increased from around 600 in February 2019 to 1800 currently.
