

# SIA Employer Topline Findings: 3 September 2018

The individual and employer surveys have been launched and we have a total of 460 responses from individuals and 146 from employers. This update pertains only to the survey data from the employer strand of the project. Findings should be interpreted with caution. The figures have not yet been weighted and as coding has not been applied to the findings.

## Employers

### Overview

Mainstage fieldwork for the employer survey launched on 20 August 2018. Following a briefing, interviewers commenced calling employers and individual respectively to invite them to take part in the survey.

This question was an open-ended question and has not been coded yet, so we are unable to provide numerical data at this time. However, some of the skills that have been repeatedly mentioned as important include:

- Good communication skills (both verbal and written) – very popular
- Customer relations / service / personality skills – also very popular
- IT skills
- First aid
- Conflict management and avoidance
- Diligence / Integrity / Good work ethic
- English – literate
- Tolerance
- Drivers licence
- Presents well / good appearance
- Common sense / ability to think on feet / proactive

**C2. And what skills do you think your [INSERT PRIMARY SECTOR FROM B3DUM] staff would benefit from further training to perform their job at the necessary level?**

As with question C1, this was an open-ended question. Participants find this more difficult to answer than C1, and not surprisingly some of the areas that they thought their staff could do with more training in were the same areas that they mentioned were important in C1. Some repeated responses include

- More / basic first aid - popular
- Communication
- Customer service
- Counter terrorism / anti-terrorism
- English / basic reading and writing
- Health and safety
- Surveillance
