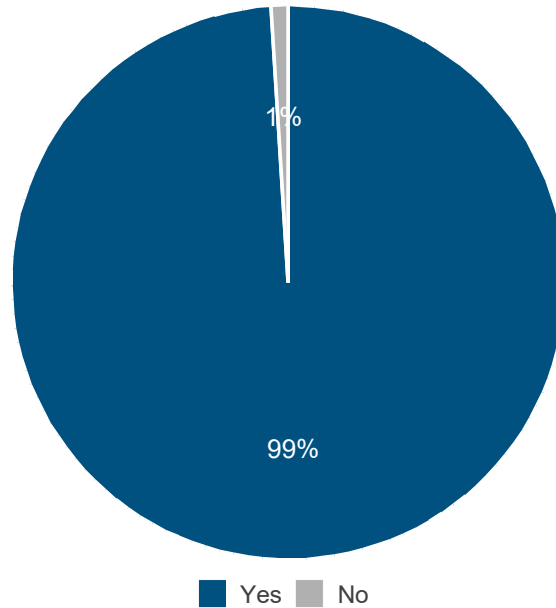
New licence-linked

Survey background & information

- SIA launched a two-stage consultation help to determine the content of the next generation of licence-linked qualifications.
- Respondents were given access to draft specifications for each of the licence-linked qualifications and then given the opportunity to rate and comment upon various aspects within each of those specifications.
- Changes were made to the specifications after the first round of consultation, then participants were given an opportunity to review these updated documents.
- The charts that follow are based on the second round of consultation.
- The fieldwork period for wave 2 of this consultation ran from 14th January 2018 until 11th February 2019
- Overall 4,280 responses were received for wave 2

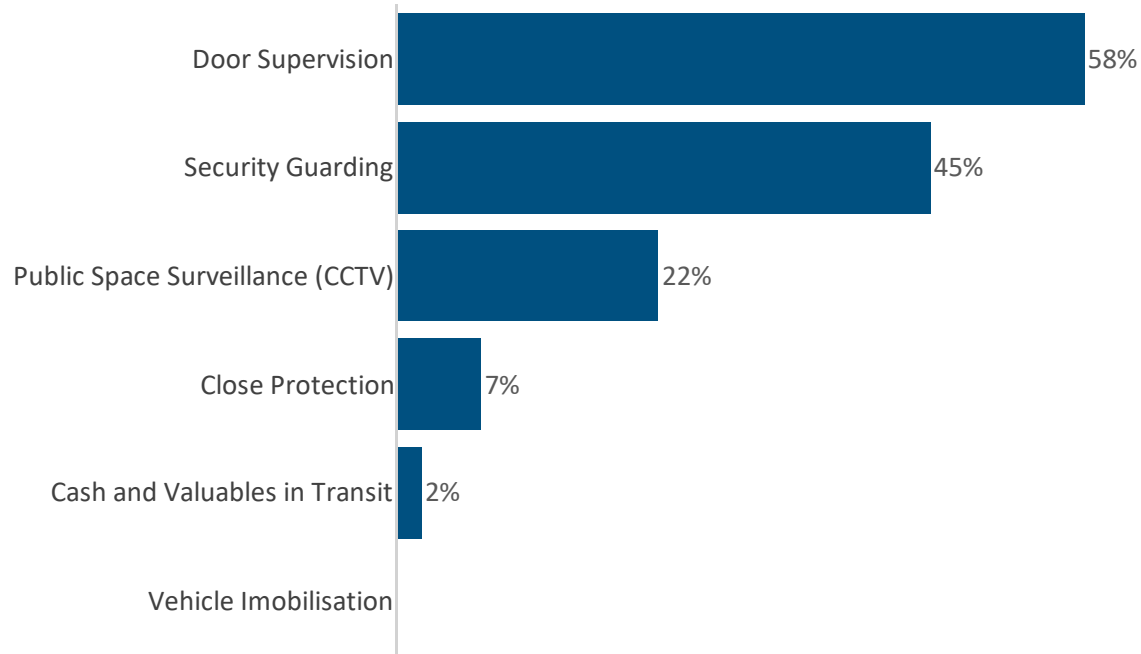

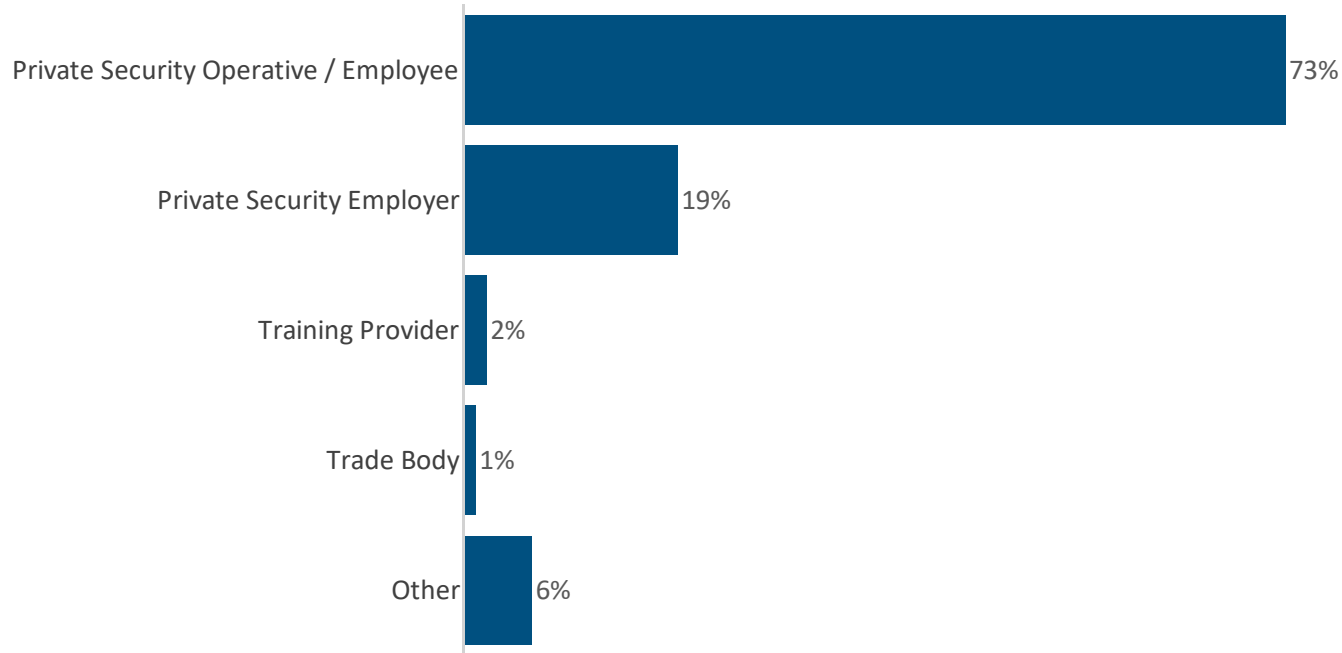

Which SIA licensable sector do you work in?



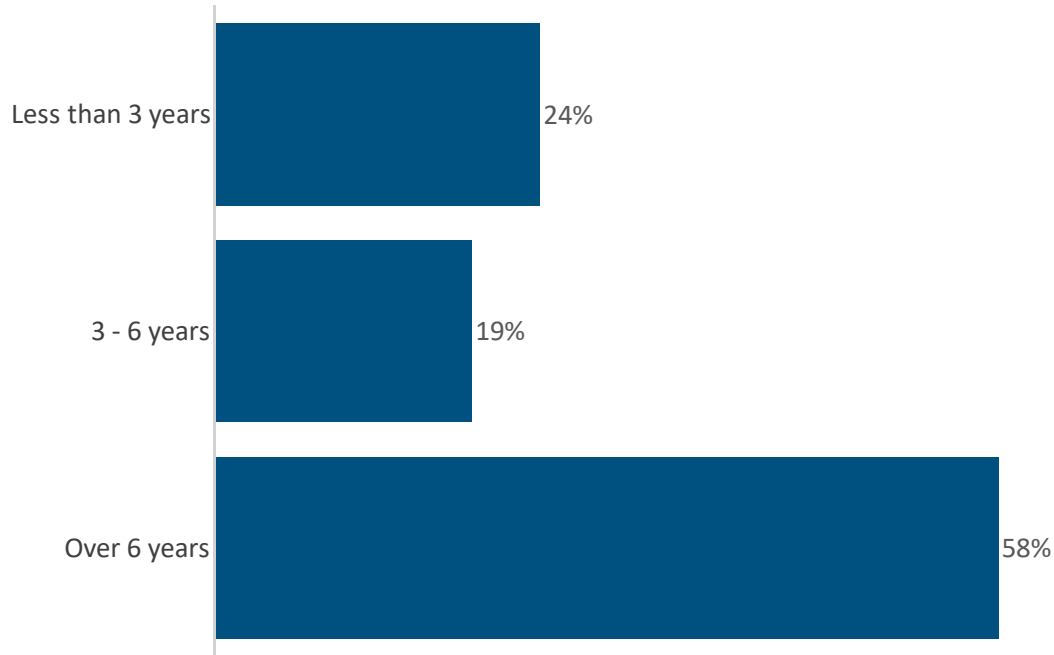

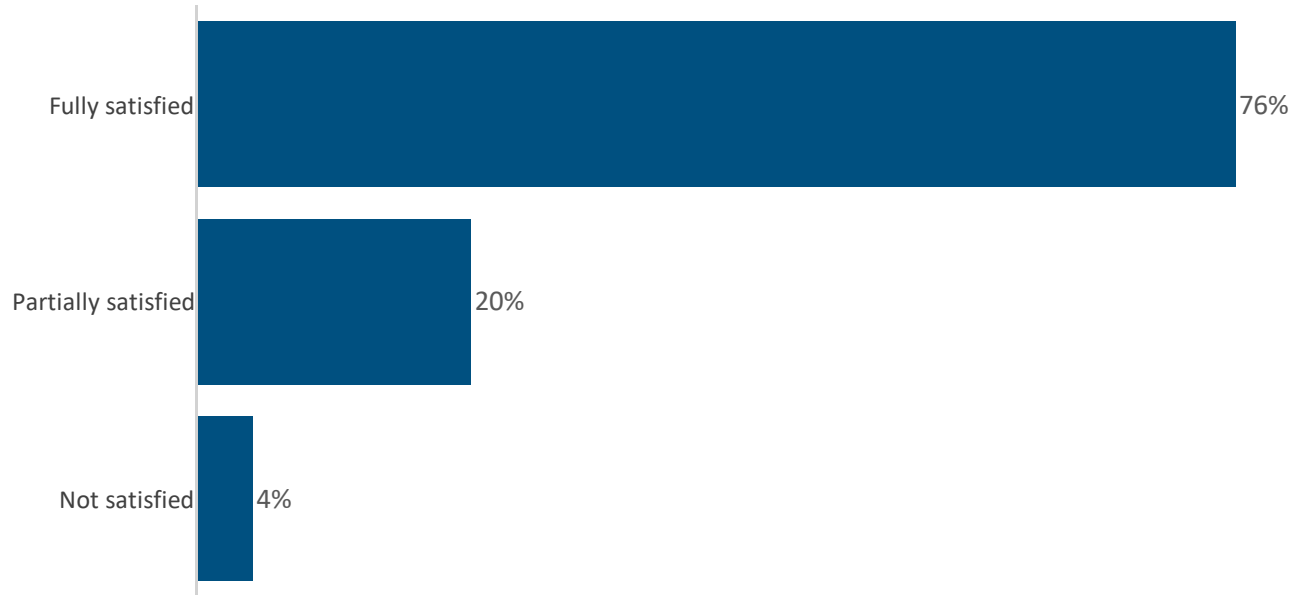
How long have you been working in the private security industry?

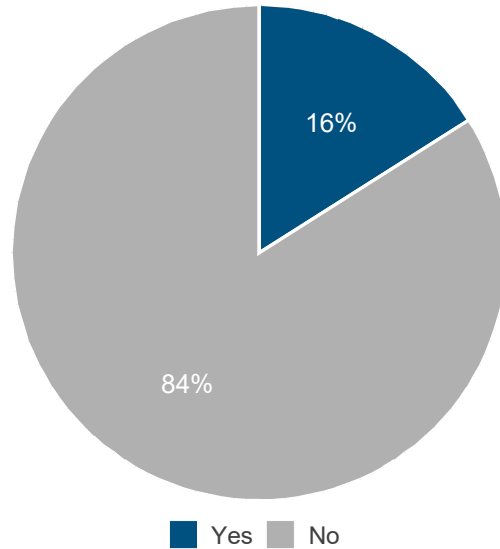

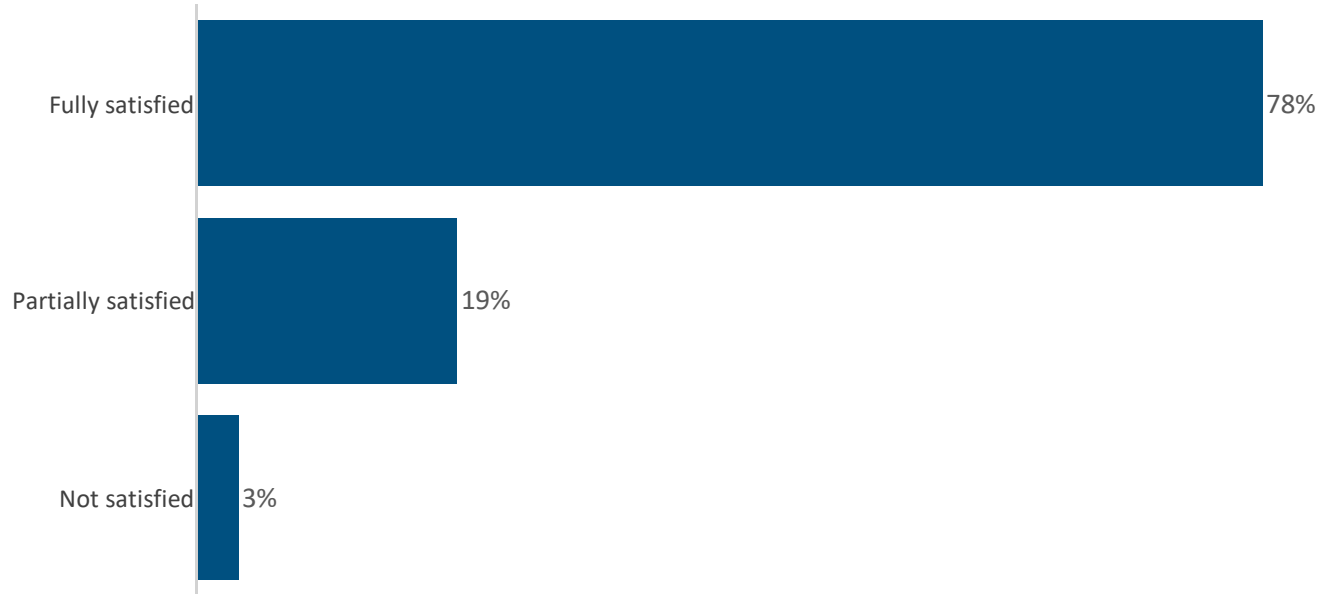
Common Security Industry Knowledge: Has anything been left out of the specification that should have been included?

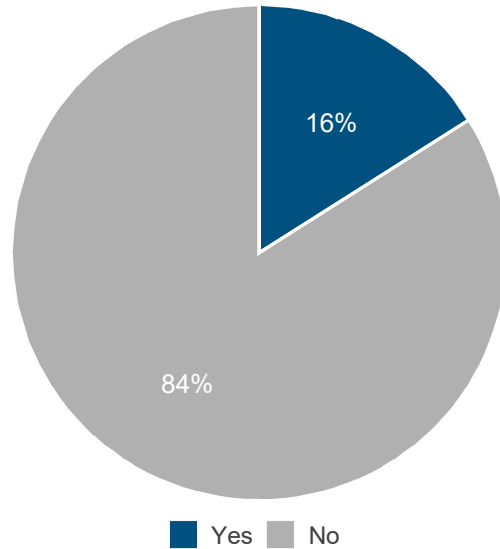
Public Space Surveillance (CCTV) Operators

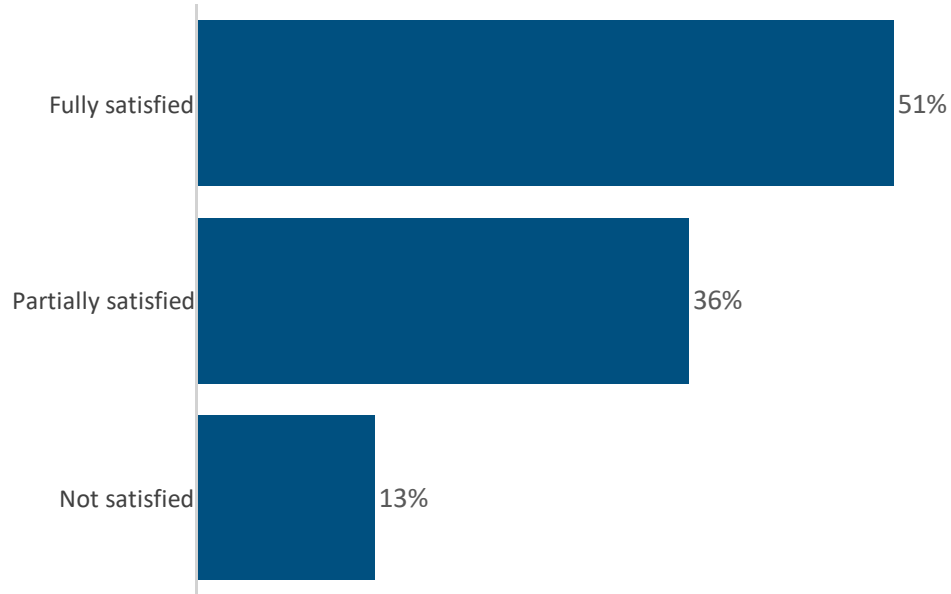

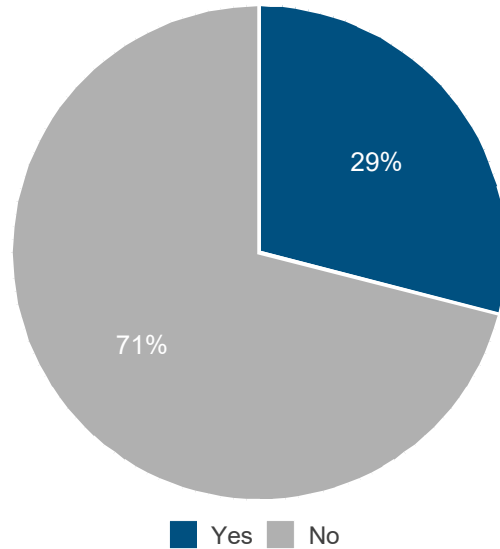
Close Protection Operatives – WITHOUT Licence Integration

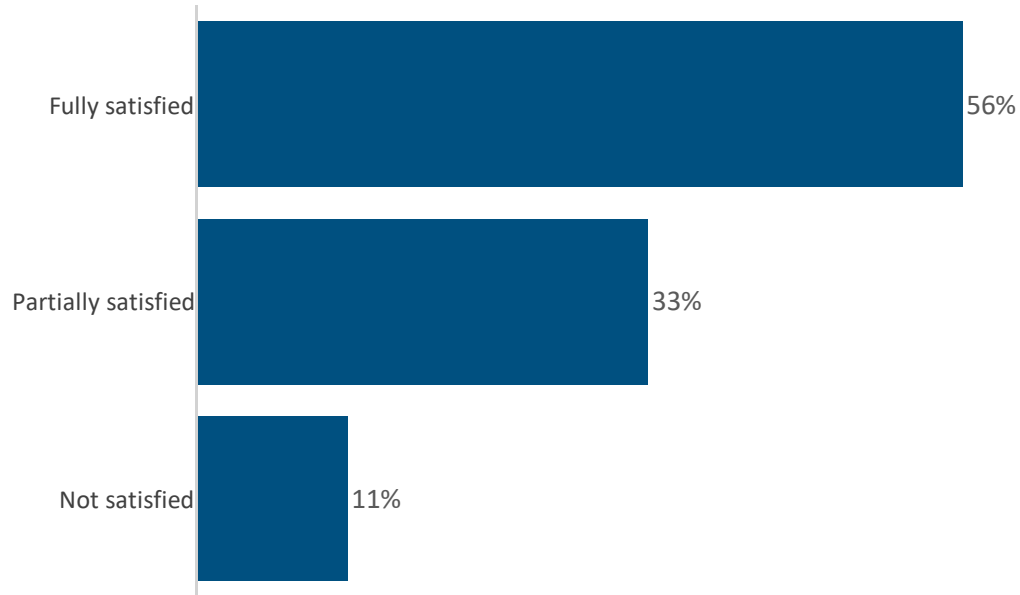

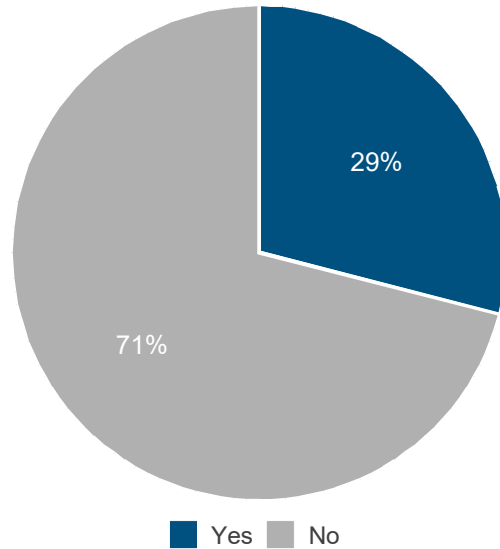

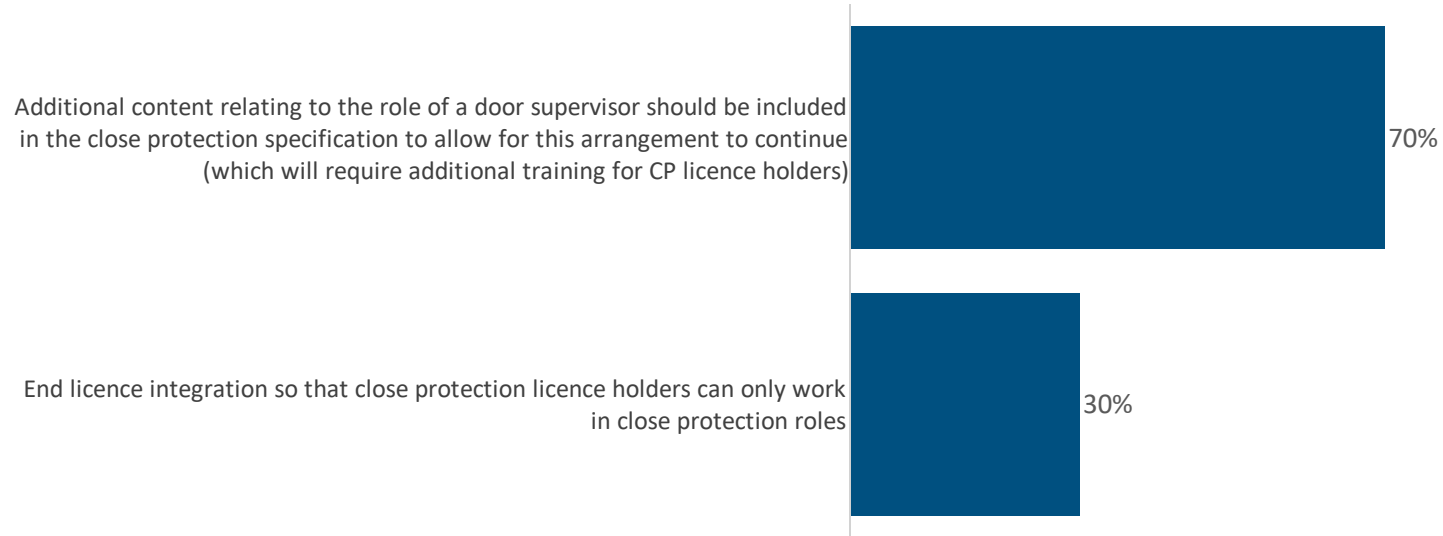

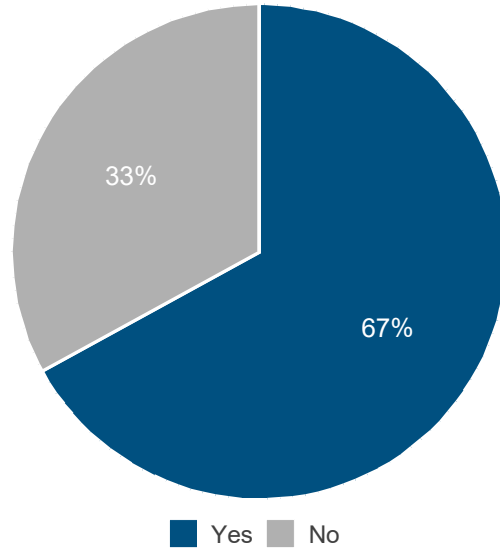

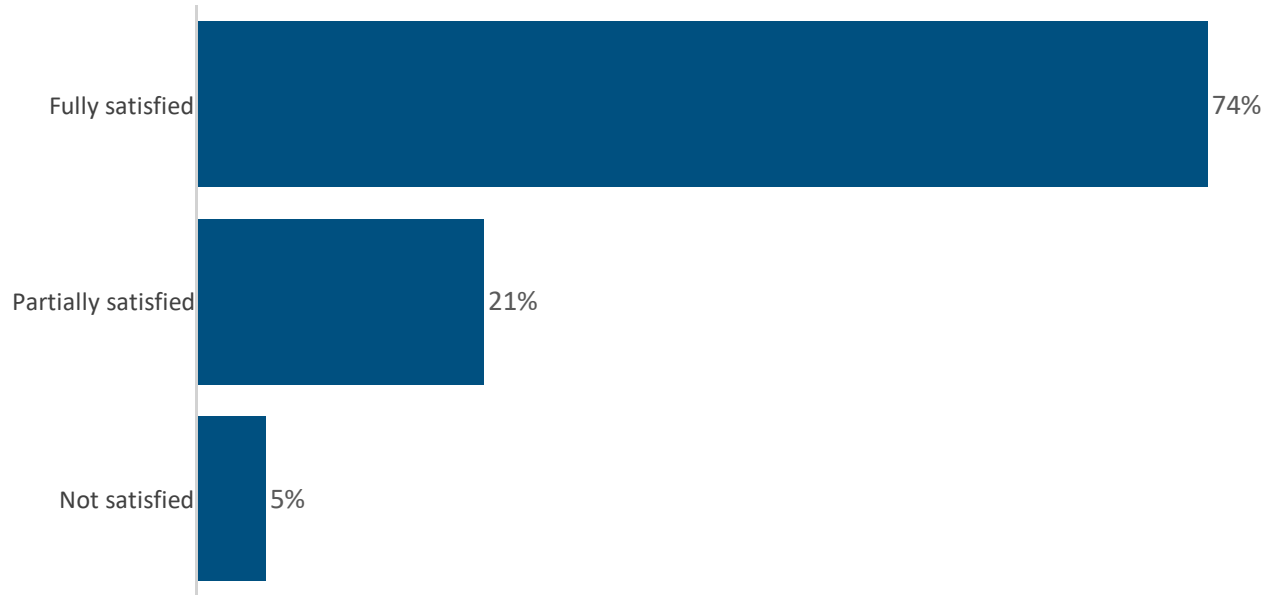

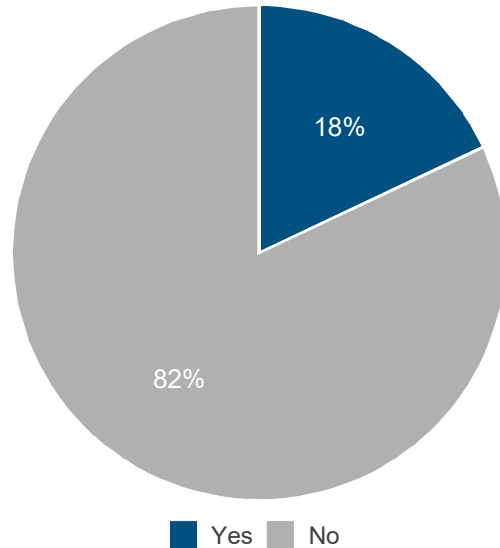

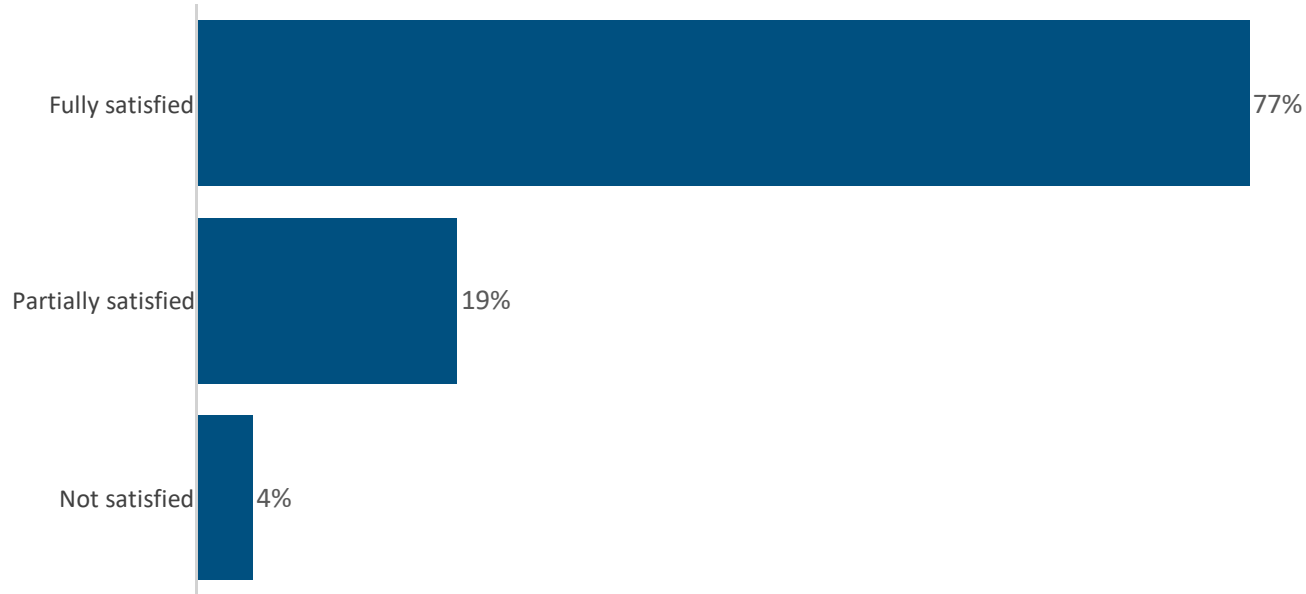

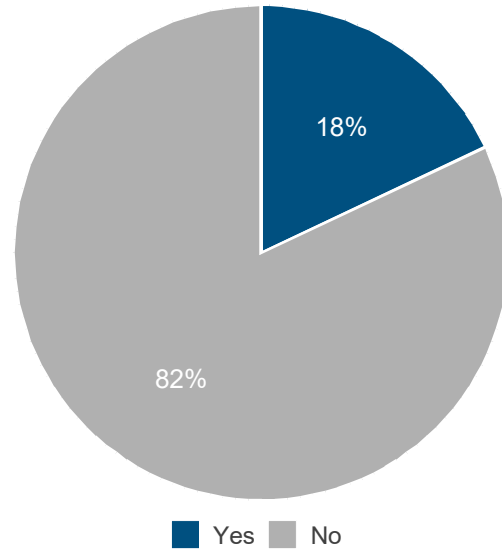

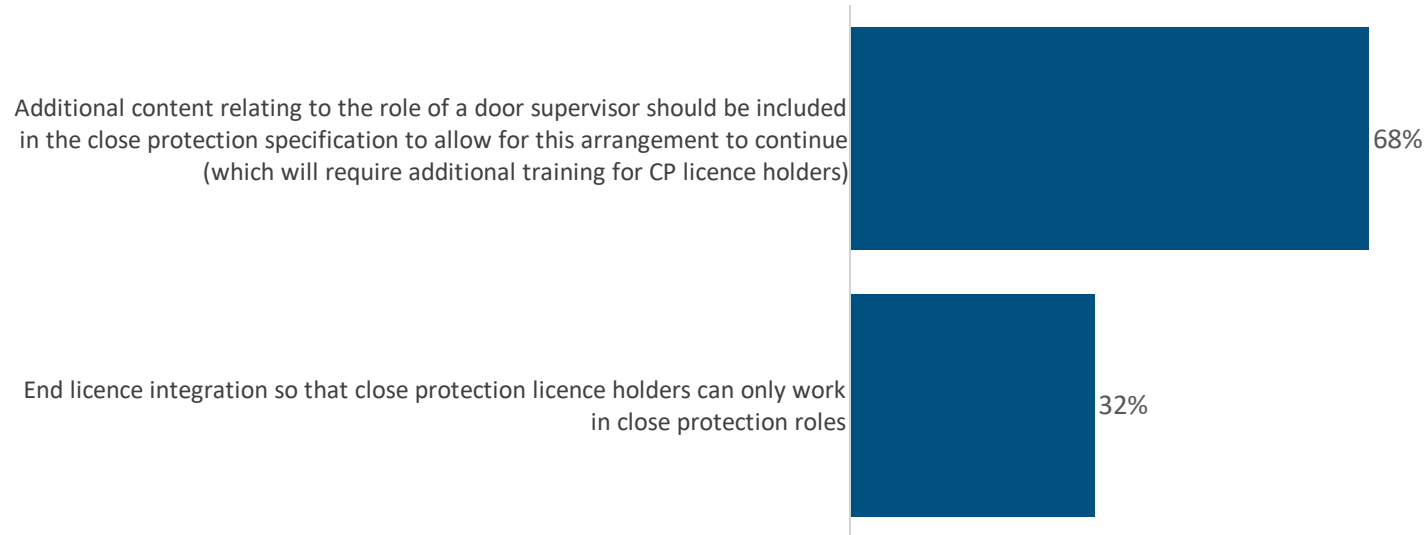

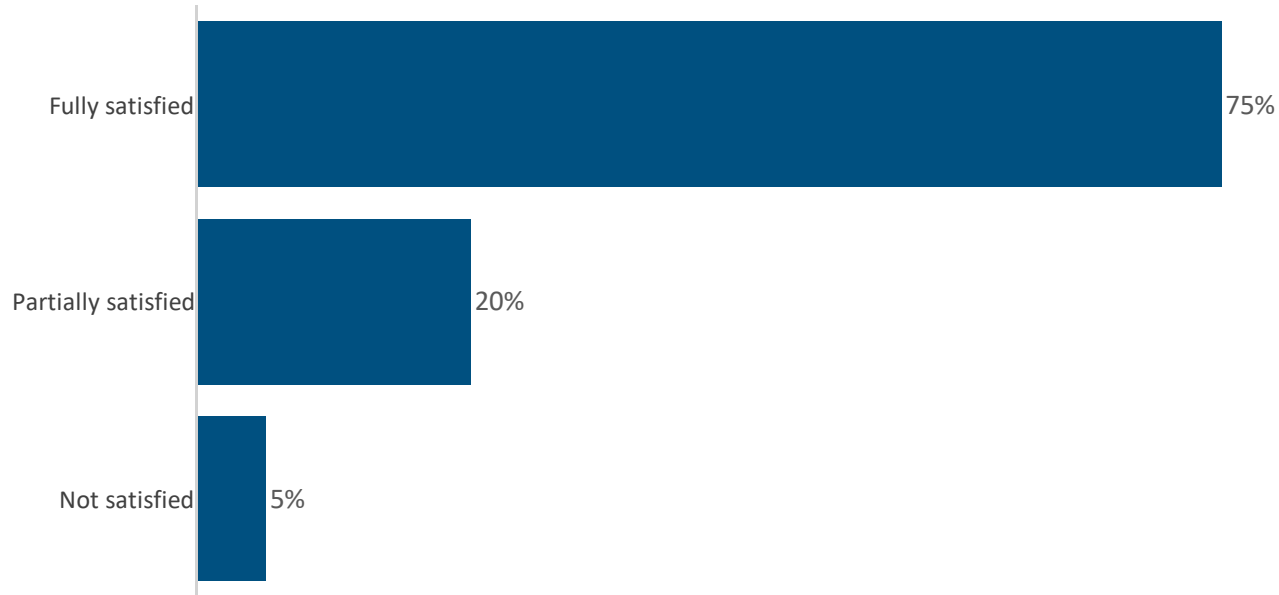
Door Supervisors: Do you think additional content relating to the role of a door supervisor should be included in the close protection specification to allow for this arrangement to continue?

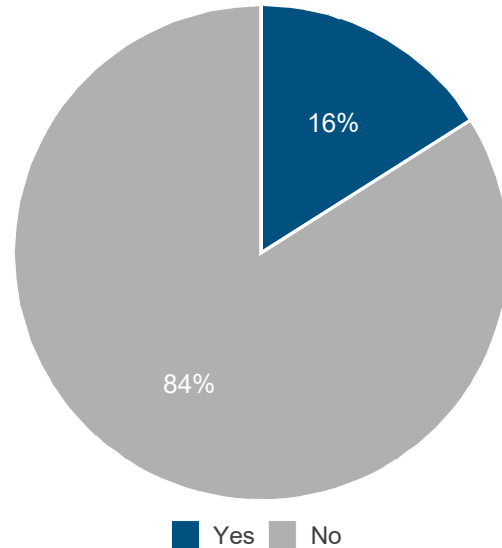

Security Officers (previously security guarding): Are you fully satisfied, partially satisfied or not satisfied with the specification as a whole?



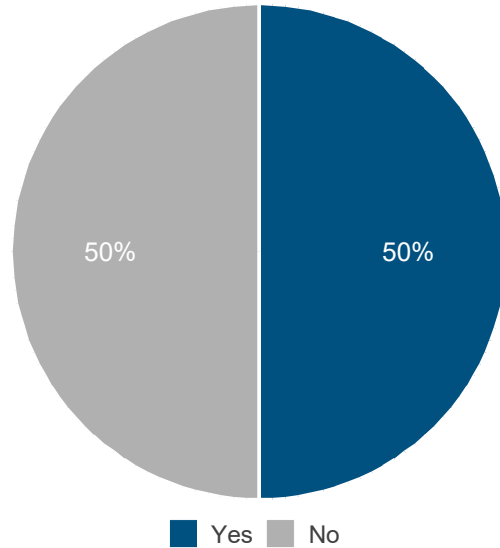

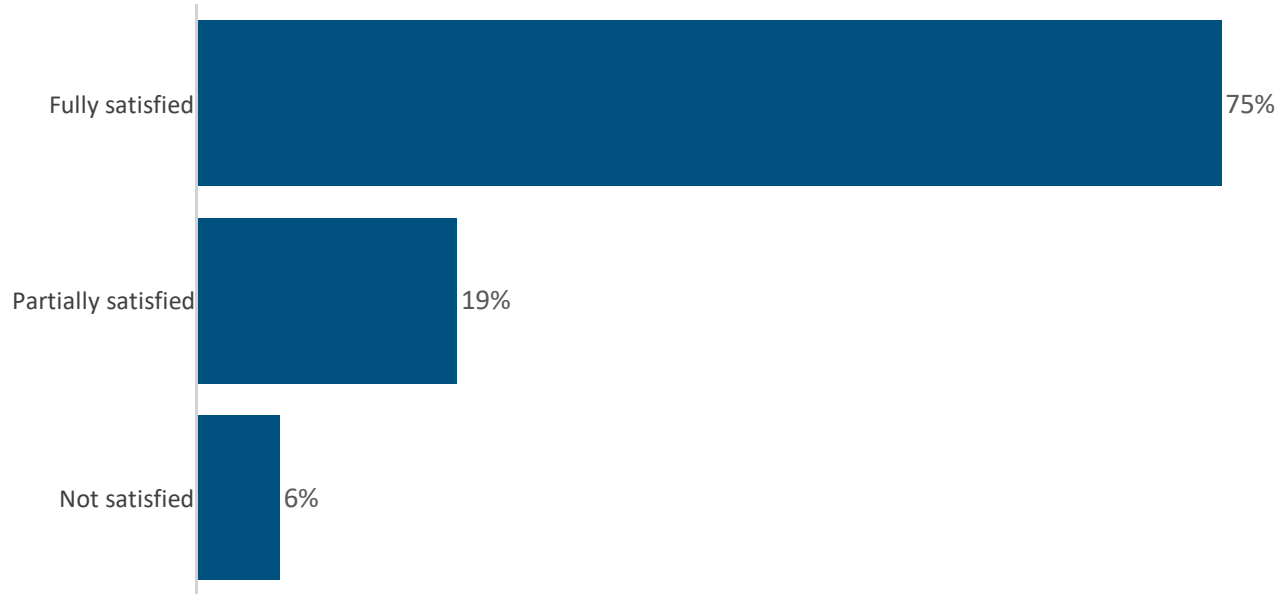
Security Officers (previously security guarding): Do you think there should be a compulsory physical intervention requirement for security officer licence holders?

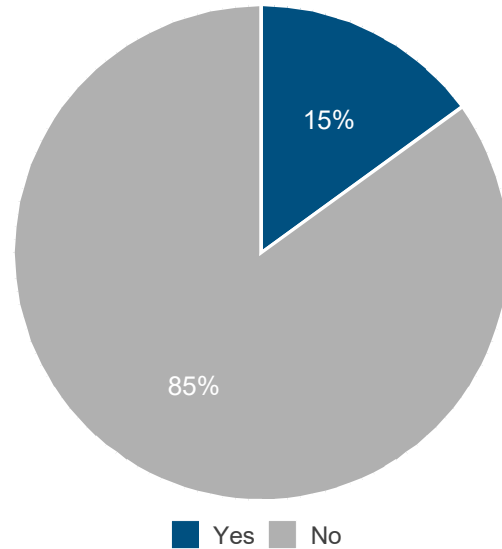
Physical Intervention Skills

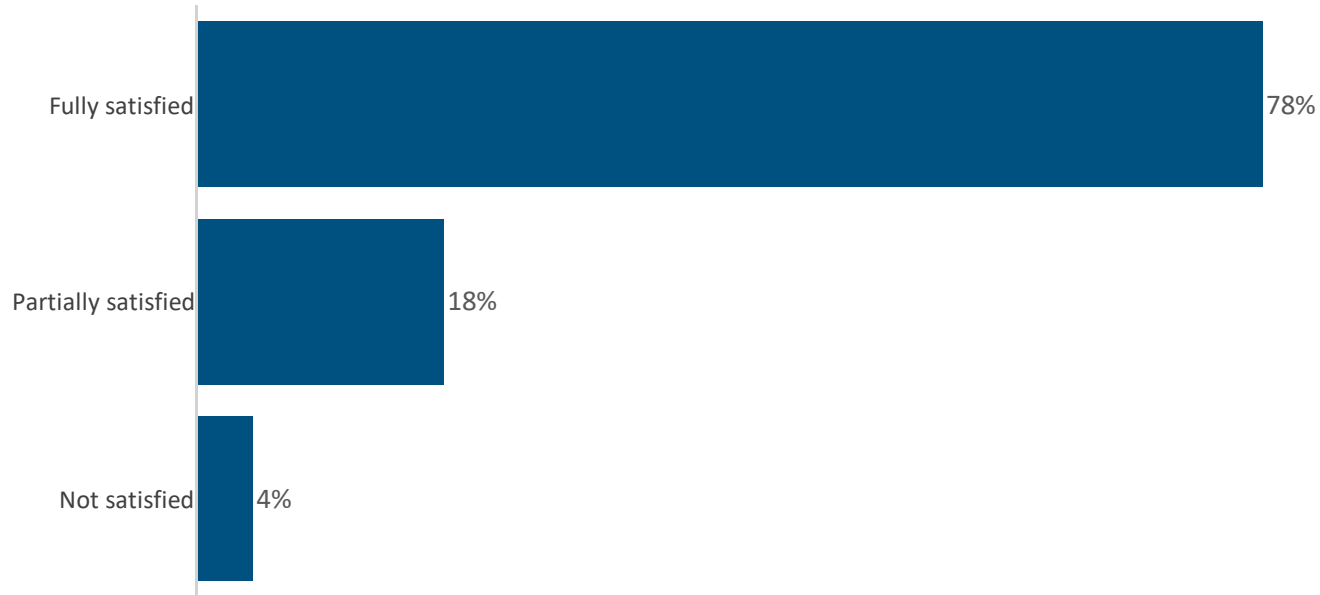

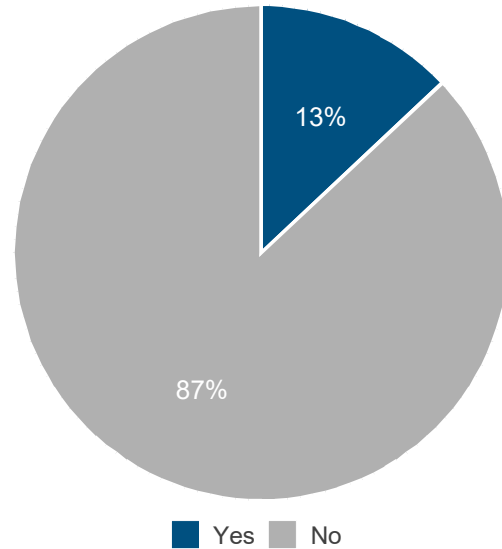
