# Intro

---

We are pleased to introduce the 2020/21 MAPPA Annual Report for the Gwent Wales Multi-Agency Public Protection Arrangements Strategic Management Board.

2021 has again been a year of great challenge with the continuation of the COVID-19 global pandemic and the impact this has had upon our communities and the way in which we work. It has impacted upon many organisations and has consequently led to changes in the way services are conducted. However, during these unprecedented times, the effectiveness of MAPPA has not been impacted. This is due to the commitment from all organisations involved in ensuring that public protection is our utmost priority to keep our communities safe.

This report outlines the work the Strategic Management Board has undertaken to improve the effectiveness of MAPPA during the year in managing violent and sexual offenders to both reduce reoffending and protect the public. It also offers the opportunity for us to demonstrate our accountability to the local communities we serve.

Protecting the public is essential to the MAPPA Responsible Authority (Police, Prison and Probation Service) and everything we do is focused on ensuring the continued safety of our communities. This is supported by the valued contribution of the Duty to Co-operate and other agencies. Sexual and violent offending forms a small percentage of the crimes dealt with by the four constabularies across Wales. However, the devastating impact these incidents have on both victims and communities is huge. Members of the public can be assured, through this report, that work continues 24 hours a day, seven days a week to protect the communities we live in.

It is never possible to eliminate entirely the risks posed by serious offenders. However, what can be expected is that all reasonable steps have been taken to reduce the risk of serious harm to the public from known offenders and promote rehabilitation. Therefore, this report not only contains statistical information about those who are managed under MAPPA during the last business year, but it also provides information about how these arrangements work in practice locally.

There have been significant developments following an independent review of the management of individuals involved in counter terrorism. As such, the Probation Service has created a specialist, dedicated and highly skilled National Security Division which will provide an enhanced level of management and intervention for the most high-risk, complex and high-profile sentenced individuals in the community. Specialist staff will deliver an enhanced set of national standards to the

management of terrorist offenders, serious organised criminals and other critical public protection cases. MAPPA will be key to the multi-agency management of individuals in this cohort.

The Strategic Management Board's achievements reflect the significant contributions made by all agencies involved in MAPPA across Gwent and we would like to thank all our partners who have contributed to these arrangements over the last year. The breadth of experience and expertise in managing MAPPA cases is exceptional and there is no doubt of the commitment agencies demonstrate to achieve the highest of standards. We also trust that this report illustrates the commitment and professionalism of our staff whose demanding and complex work rarely receives public attention. Their dedication is key to ensuring our communities remain safe.

In recommending this report to you, we hope it provides a valuable insight into our work and offers reassurance that public protection and the needs of victims remain our highest priorities.

# What is MAPPA?

## MAPPA background

MAPPA (Multi-Agency Public Protection Arrangements) are a set of arrangements to manage the risk posed by the most serious sexual, violent and terrorist offenders (MAPPA-eligible offenders) under the provisions of sections 325 to 327B of the Criminal Justice Act 2003.

They bring together the Police, Probation and Prison Services in each of the 42 Areas in England and Wales into what is known as the MAPPA Responsible Authority.

A number of other agencies are under a Duty to Co-operate (DTC) with the Responsible Authority. These include Social Services, Health Services, Youth Offending Teams, Jobcentre Plus and Local Housing and Education Authorities.

Local Strategic Management Boards comprising senior representatives from each of the Responsible Authority and DTC agencies are responsible for delivering MAPPA with their respective areas. The Responsible Authority is also required to appoint two Lay Advisers to sit on each MAPPA area Strategic Management Board (SMB).

Lay Advisers are members of the public appointed by the Minister with no links to the business of managing MAPPA offenders who act as independent, yet informed, observers; able to pose questions which the professionals closely involved in the work might not think of asking. They also bring to the SMB their understanding and perspective of the local community (where they must reside and have strong links).

## How MAPPA works

MAPPA-eligible offenders are identified and information about them is shared between agencies to inform the risk assessments and risk management plans of those managing or supervising them.

That is as far as MAPPA extend in the majority of cases, but some cases require more senior oversight and structured multi-agency management. In such cases there will be regular MAPPA meetings attended by relevant agency practitioners.

There are 3 categories of MAPPA-eligible offender:

- **Category 1** - registered sexual offenders;
- **Category 2** – mainly violent offenders sentenced to 12 months or more imprisonment or a hospital order; and
- **Category 3** – offenders who do not qualify under categories 1 or 2 but who currently pose a risk of serious harm.

There are three levels of management to ensure that resources are focused where they are most needed; generally those presenting the higher risks of serious harm.

- **Level 1** is where the offender is managed by the lead agency with information exchange and multi-agency support as required but without formal MAPPA meetings;
- **Level 2** is where formal MAPPA meetings are required to manage the offender.
- **Level 3** is where risk management plans require the attendance and commitment of resources at a senior level at MAPPA meetings.

MAPPA are supported by ViSOR. This is a national IT system to assist in the management of offenders who pose a serious risk of harm to the public. The use of ViSOR increases the ability to share intelligence across organisations and enables the safe transfer of key information when high risk offenders move, enhancing public protection measures. ViSOR allows staff from the Police, Probation and Prison Services to work on the same IT system for the first time, improving the quality and timeliness of risk assessments and interventions to prevent offending.

## MAPPA and Terrorism

In response to the terrorist attack committed by Usman Khan at Fishmongers' Hall on 29 November 2019, the Home Secretary and the Lord Chancellor commissioned Jonathan Hall QC, who is the Independent Reviewer of Terrorism Legislation, to undertake a review of MAPPA and the management of known terrorists and other extremist offenders (TACT Offenders). The terrorist attack committed by Sudesh Amman in Streatham High Road on 2 February 2020

served to reinforce the need for the review, since both Khan and Amman had been managed under MAPPA. The government published the report on 2 September 2020 and published a response to it on 9 December. Both documents are available at <https://www.gov.uk/government/publications/multi-agency-public-protection-arrangements-review>. The report made a number of recommendations, several of which have been or are being implemented via the Counter-Terrorism and Sentencing Act 2021 and the Police, Crime, Sentencing and Courts Bill. Others have already been introduced by the creation of the National Security Division (NSD) in the Probation Service to manage terrorist offenders. The Secretary of State has also revised the statutory MAPPA Guidance on terrorist offenders.

The Probation Service, via the NSD, has created a specialist dedicated and highly skilled workforce, which

provides an enhanced level of management and intervention for the most high-risk, complex and high-profile offenders in the community. This will include the management of terrorist connected and terrorist risk offenders. Five Probation Service national security units have been established across England & Wales during 2020/21. The NSD and Counter-Terrorism Policing will be working closely with local Strategic Management Boards to ensure the robust management of terrorism cases. The NSD also manages serious organised crime and the most high risk and high profile public protection cases.

# Explanation commentary on statistical tables

---

## MAPPA background

The totals of MAPPA-eligible offenders, broken down by category, reflect the picture on 31 March 2021 (i.e. they are a snapshot). The rest of the data covers the period 1 April 2020 to 31 March 2021.

**(a) MAPPA-eligible offenders** – there are a number of offenders defined in law as eligible for MAPPA management, because they have committed specified sexual and violent offences or they currently pose a risk of serious harm, although the majority are actually managed at Level 1 without formal MAPPA meetings. These figures only include those MAPPA eligible offenders living in the community. They do not include those in prison or detained under the Mental Health Act.

**(b) Registered Sexual Offenders (RSOs)** – those who are required to notify the police of their name, address and other personal details and to notify of any subsequent changes (this is known as the “notification requirement.”) These offenders are assessed and managed by the police. They may also be managed by probation or health services if they are subject to licence or a hospital order. Failure to comply with the notification requirement is a criminal offence that carries a maximum penalty of 5 years’ imprisonment.

**(c) Violent Offenders** – this category includes violent and terrorist offenders sentenced to imprisonment or detention for 12 months or more, or detained under a hospital order. It also includes a small number of sexual offenders who do not qualify for registration. These offenders are assessed and managed by the Probation Service, Youth Offending Team or Mental Health Services.

**(d) Other Dangerous Offenders** – offenders who do not qualify under the other two MAPPA-eligible categories, but who currently pose a risk of serious harm which requires management via MAPPA

meetings. These offenders are assessed and managed by whichever agency has the primary responsibility for them.

**(e) Breach of licence** – offenders released into the community following a period of imprisonment will be subject to a licence with conditions (under probation supervision). If these conditions are not complied with, breach action will be taken and the offender may be recalled to prison.

**(f) Sexual Harm Prevention Order (SHPO) (including any additional foreign travel restriction).** Sexual Harm Prevention Orders (SHPOs) and interim SHPOs replaced Sexual Offence Prevention Orders. They are intended to protect the public from offenders convicted of a sexual or violent offence who pose a risk of sexual harm to the public by placing restrictions on their behaviour. They require the offender to notify their details to the police (as set out in Part 2 of the 2003 Act) for the duration of the order.

The court must be satisfied that an order is necessary to protect the public (or any particular members of the public) in the UK, or children or vulnerable adults (or any particular children or vulnerable adults) abroad, from sexual harm from the offender. In the case of an order made on a free standing application by a chief officer or the National Crime Agency (NCA), the chief officer/NCA must be able to show that the offender has acted in such a way since their conviction as to make the order necessary.

The minimum duration for a full order is five years. The lower age limit is 10, which is the age of criminal responsibility, but where the defendant is under the age of 18 an application for an order should only be considered exceptionally.

**(g) Notification Order** – this requires sexual offenders who have been convicted overseas to register with the police, in order to protect the public in the UK from the risks that they pose. The police may apply to the court

for a notification order in relation to offenders who are already in the UK or are intending to come to the UK.

**(h) Sexual Risk Order (including any additional foreign travel restriction)**

The Sexual Risk Order (SRO) replaced the Risk of Sexual Harm Order (RoSHO) and may be made in relation to a person without a conviction for a sexual or violent offence (or any other offence), but who poses a risk of sexual harm.

The SRO may be made at the magistrates' court on application by the police or NCA where an individual has committed an act of a sexual nature and the court is satisfied that the person poses a risk of harm to the public in the UK or children or vulnerable adults overseas.

A SRO may prohibit the person from doing anything described in it, including travel overseas. Any prohibition must be necessary to protect the public in the UK from sexual harm or, in relation to foreign travel, protecting children or vulnerable adults from sexual harm.

An individual subject to an SRO is required to notify the police of their name and home address within three days of the order being made and also to notify any changes to this information within three days.

A SRO can last for a minimum of two years and has no maximum duration, with the exception of any foreign travel restrictions which, if applicable, last for a maximum of five years (but may be renewed).

The criminal standard of proof continues to apply. The person concerned is able to appeal against the making of the order and the police or the person concerned are able to apply for the order to be varied, renewed or discharged.

A breach of a SRO is a criminal offence punishable by a maximum of five years' imprisonment. Where an individual breaches their SRO, they will become subject to full notification requirements.

Individuals made subject of a SRO are now recorded on VISOR as a Potentially Dangerous Person (PDP).

**(i) Lifetime notification requirements revoked on application**

A legal challenge in 2010 and a corresponding legislative response means there is now a mechanism in place that allows qualifying sex offenders to apply for a review of their notification requirements. Persons do not come off the register automatically. Qualifying offenders may submit an application to the police to review their indefinite notification requirements. The police review the application and decide whether to revoke the notification requirements. This decision is made at the rank of Superintendent. Those who continue to pose a significant risk will remain on the register for life, if necessary.

Individuals will only become eligible to seek a review once they have been subject to indefinite notification requirements for a period of at least 15 years for adults and 8 years for juveniles. This applied from 1 September 2012 for adult offenders.

The Gwent MAPPA Strategy Management Board's (SMB) vision of ensuring offenders are managed at the right level with the appropriate amount of resources underpins the work of the Multi Agency Public Protection Panels (MAPPA) throughout the Probation Delivery Unit (PDU). The MAPPA's are jointly chaired by the Probation and the Police, and each MAPPA Chair ensures the inclusion of the Responsible Authorities (RA)/ Duty to Co-operate (DTC) agencies in order to establish a robust risk management plan and co-working approach in managing offending behaviour and with the screening of cases discussed during a MAPPA meeting.

There is a mutual respect and understanding between the RAs and DTCs about the challenges experienced by each agency, especially housing, which has created a more responsive relationship and resources being utilised in a more cost effective and risk-appropriate manner.

Senior representatives from agencies involved in managing/ supporting offenders are invited to SMB meetings to present their organisation's aims and objectives and demonstrate how their input feeds into risk management plan. This in turn increases the range of available resources to encourage desistance and victim safety.

Gwent's Key Performance Indicators (KPIs) continues to evidence positive attendance of all relevant agencies at MAPPA meetings and is reflective of how the MAPPA ethos enables the management of offenders and the protection of the public. This is demonstrated by the commitment of partners to attend meetings, which are sometimes called at short notice, to ensure there is a robust risk management plan in place. The KPIs also indicate the responsive nature of cases referred and scheduled for MAPPA meetings.

The Gwent MAPPA unit is managed by the Wales Public Protection and Approved Premises (PPAP) Team and is based within Gwent Probation, which ensures open communication and consistency of practice.

As the lead agency, Gwent Probation, govern and co-ordinate the management of all offender management processes as well as MAPPA cases. This enables an effective and cohesive approach to the identification and management of risk, to reduce reoffending, protect the public and safeguard victims.

Gwent Probation is consistently striving to improve the service provisions and develop practices that complement the MAPPA arrangements, like the introduction of a single point of contact for the transition of MAPPA cases throughout England and Wales. There are also some exceptional cases that are no longer under statutory management of Probation and are solely managed by the Police. When these cases are identified as requiring additional management, Gwent Probation continue to provide voluntary supervision for those offenders within the community, thus providing ongoing support, monitoring and liaison with the appropriate agencies.

The Management of Sexual and Violent offender officers (MOSOVOs) is managed by the Police Public Protection Unit (PPU) which is closely supported by other policing teams. These include the Digital Media and Cybercrime Investigators, who can scrutinise and monitor the use by offenders of telecommunications and the internet. Targeting teams are often deployed to enhance the work of MOSOVOs to ensure compliance with restrictive orders, while the Neighbourhood policing teams play an important role in supporting the work of specialist staff from all agencies within MAPPA. This has

resulted in many successful outcomes, both in deterring further offending and in identifying and addressing breaches of restrictive orders and notification requirements.

Gwent Probation and the Police continues to work effectively with partners and remains committed to the effective management of MAPPA to reduce the risks posed within the community.

HMPPS Prisons in Wales are also integral to the management of offenders in custody and contribute to the risk management plans of offenders being released into the community, to ensure continuity of interventions and sharing of information.

COVID 19 has presented many challenges in relation to the imposed restrictions to contain the spread of the virus, however in Gwent and across Wales special measures have been implemented including the use of technology to ensure the MAPPA arrangements continue to be undertaken.

Evidence of continual improvements are set out in our MAPPA Annual Strategic Plan. Sharing good practice throughout Gwent and across Wales ensures local communities and the wider criminal justice system have confidence in MAPPA and Public Protection work. We look forward to building on this further in 2021/2022.

## Sue Harris, Partnership Manager DWP

As a Duty to Co-operate Organisation I am pleased to say that I have supported the transition of numerous offenders managed by MAPPA from Prison to making claims for relevant benefits. This has included:

- Liaising with Universal Credit, Pensions and Personal Independence Payments to support individuals who would otherwise struggle with the claim process
- Arranging Work Capability Assessments for individuals with health conditions
- Working closely with Probation to ensure correct payments are made and more frequently where budgeting is a problem
- Assisting with Managed Payments to Landlords to protect tenancies
- Liaising with local Jobcentre staff to provide up to date information supporting both them and the offender.

This final page aims to provide an overview of the work undertaken in the last business year and provide some insight into plans of work for the following year. May 2020 saw the end of a 7-year term for our Lay Advisor, Dudley Harmston. The Criminal Justice Act 2003 requires the minister to appoint two Lay Advisors to each Responsible Authority (RA) area. Lay Advisors are voluntary public appointments and are unpaid. Their role is to monitor the effectiveness of MAPPA and to be consulted regarding any change made in order to bring about improvement. Lay Advisors act as "critical friends" in order to pose questions and challenge professionals. They routinely become involved in audits and observe level 2 and 3 meetings in order to monitor and evaluate the process. Dudley played an important role in the monitoring and evaluation of MAPPA processes in Gwent, including assisting with audits. He played an active role in SMB meetings and managed to strike a helpful balance of supporting the board whilst challenging and holding us to account when necessary. I would like to take this opportunity to thank Dudley for his help and support over the years. The Lay Advisor recruitment process began in June 2020 and there was an overwhelming response from a number of strong candidates. In June 2020 our first successful candidate was appointed by the Minister of State for Justice, followed by our second appointment being in May 2021. The successful candidates were Ieuan Watkins and David Thomas. I look forward to working with both individuals in the future.

Finally, I'd like to thank all of the panel chairs and members for their hard work over the last year. Collaboration with partners is essential in ensuring the effective delivery of MAPPA arrangements and the panel chairs have upheld their professionalism and have adapted to alternative means of chairing as a result of COVID19.

I look forward to the upcoming year to develop MAPPA arrangements further within Gwent.
