Dear Dear

I am writing about your email of 25 June 2021, requesting the following information:

Please can you provide any details for have on YFM660 Grizzly Quad, military registration GE64AB units where based etc

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence (MOD), and I can confirm that information in scope of your request is held. This is attached for each vehicle, as follows:

Annex A - Ownership History (redacted)

Annex B - Fault History (redacted)

Annex C - Inspection History

Annex D - Service History

It has proved necessary to withhold some information related to your request. This is some of the Vehicle History (Annex A) which has been redacted under qualified exemption Section 26(1)(a) and (b) (Defence) of the FOI Act. Commercially sensitive information in the Fault History (Annex B), relating to contractor repair times, has been withheld under qualified exemption Section 43(2) (Commercial Interests).

Section 26 applies to information that if disclosed would or would likely; prejudice the defence of the British Islands or any colony; and/or the capability, effectiveness or security of the Armed Forces of the Crown or any forces cooperating with them. Section 43 concerns information which if disclosed would or would likely; prejudice the commercial interests of any person (including defence contractors and the public authority holding it).

As these exemptions are qualified, it was necessary to undertake a Public Interest Test to determine whether the balance for withholding the information outweighs that for disclosure. General arguments in favour of release were that full disclosure would demonstrate the MOD's commitment to openness and transparency; and make the UK Government more accountable to the electorate. The FOI Act also contains a presumption for release.

However, releasing the Vehicle Usage History (Annex A) would divulge information that could be used to compromise the ability of UK Armed Forces to carry out operations safely.

The Fault History (Annex B) provides details of the time taken by MOD contractors to rectify fault reports. This data, along with previously published information, could be used to make reasonable assumptions about hourly labour rates. As market sensitive information, this could then be exploited by commercial competitors to undercut the contractor when bidding for similar work.

Given the arguments described above, on balance, it was determined that the information should be withheld. The level of prejudice against release of this exempted information has been set at the higher level of "would" rather than "would be likely to".
