Thank you for your email of 17 February 2021, requesting the following information:

Thank you for your letter dated the 20th May 2020. I wish to ask further questions with regards to the contents of the letter under the Freedom of Information Act.

- 1/ I would ask if Elbit Systems Israel is the main contractor for the Joint Fire Synthetic Trainer (JFST) contract and what element or elements are being provided by Elbit Systems Limited Israel?
- 2/ I would ask you to clarify details of two of the companies named in the list you provided of companies involved with the Joint Fire Synthetic Trainer. I am unable to find information on RINA and RISIKO and ask for details of these companies including what they supply to the contract, a website address or their address and country of origin.
- 3/ I welcome the information on the contracts placed with Ferranti Technologies since 2007. I, however, would welcome the date that each contract was given to Ferranti Technologies?
- 4/ With regard to the contracts you have listed for Ferranti Technologies do any of them also have Elbit Systems Ltd (Israel) as a main or contributory company?
- 5/ The contracts you listed for Ferranti Technologies cannot all be deciphered. I have consulted the Government's official MoD list of Abbreviations and Acronyms but some of those you supply are not on that list or the list has a variety of definitions for them. I would ask for further information on the following contracts as I cannot

decipher the meaning of the Abbreviations and Acronyms and therefore the contracts themselves – see below.

'Enabling contract for support to ADAWS, CACS and SEAWOLF DBE Equipment PDS, Spares and Repairs for Ships Compass Transmission Systems Equipment Provision of Close Air Support and Emulation'

6/ With regard to the contracts with Elbit Systems UK, is Elbit Systems Ltd Israel a main or contributory company to these contracts and I would welcome the dates that

these contracts were placed.

7/ I would also ask for further details of some of the Elbit UK contracts as the information you supply is insufficient to understand the Abbreviations and Acronyms and therefore the contracts' themselves. These are:

'Provision of GFA for the Dismounted Joint Fires Integrator Competition RM Agile C2 – Elbit Systems UK Capability CCDT/607/ELB RPV Programme'

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence, and I can confirm that some information in scope of your request is held and can be found below.

- 1. Ferranti Technologies Ltd is the prime contractor for the Joint Fire Synthetic Trainer (JFST). Elbit Systems Limited Israel is a subcontractor, with work relating to technical system development, integration, test and manufacturing for the project.
- 2. RINA is a subcontractor and is responsible for integrated logistic support and safety. RINA is a UK-based company, with its headquarters in Italy.
