RE: Request for Information – RFI3622

Thank you for your request for information which was processed in accordance with the Freedom of Information Act 2000 (FOIA).

You requested the following information:

Please will you provide any information available on the 2008 sale of the **Ground Rent Rights (HM Land Registry title EGL530057)** for **Adelaide Wharf, Queensbridge Road, Hackney**, from **First Base (Adelaide Wharf) Land Limited** (often simply referred to as **First Base**, the CEO being **Mr Elliot Lipton**), to **Adelaide Wharf LLP (Mr Gregory Rack** and **Mr Paul Godfrey**).

In particular I would ideally like to know:

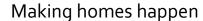
- Any information of whether the sale was encouraged or demanded by either English Partnerships / Urban Regeneration Agency, or the HCA? This may have related to the "London-Wide Initiative (LWI)" affordable housing scheme, which was set up by English Partnerships.
- Any details on the involvement Boris Johnson, in his then-capacities as the the Mayor of London and/or chair
 of the London HCA Board, had in influencing or negotiating this sale, as suggested in his answer to question
 2011/2314 in Mayor's Question Time in July 2011 (full text of the Q&A is reproduced below for your
 reference).
- Any information on how Mr Rack and Mr Godfrey found-out about the opportunity to buy the ground rent rights.

Note that according to title EGL530057, the sale was recorded on 10th December 2008, following a transfer dated 28th November 2008. I understand that, between these two dates, the powers of English Partnerships were passed to its successor, the HCA. Please, therefore, will you search the archives of both agencies.

Response

We can confirm that Homes England does not hold the information detailed in your request.

To conclude that the information is not held, we have searched with our Records team who would have the requested information if held.
