Thank you for your request for information which was processed in accordance with the Freedom of Information Act 2000 (FOIA).

You requested the following information:

RE: in relation to funding from Homes England to BCHA (Bournemouth Churches Housing Association) for the purchase and provision of a new homeless shelter in Yeovil, Somerset. https://www.somersetlive.co.uk/news/somerset-news/council-grants-nearly-400000-towards-5487973

The background is that we are a residents group who are opposed to the proposed location of the new Housing facility to be provided by BCHA who we do not believe are fit to mange their current facility and therefore not fit to manage a new expanded facility which will have a detrimental effect on a residential area of the town and the residents of the facility.

The FOI request is as follows

Provision of any information, communications that has been passed internally within Home England that pertains to the decision being made to award this funding to BCHA for the purchase of a new facility within Yeovil to replace their current Pathways facility.

Provision of any information, communications (that can be provided) that has been passed between the two parties BCHA and Homes England's in relation to the application and approval of the funding for a new facility within Yeovil to replace their current Pathways facility.

Provision of any information, communications (that can be provided) that has been passed between the two parties SSDC and Homes England's in relation to the application and approval of the funding for a new facility within Yeovil to replace their current Pathways facility.

Details of the approved funds, full details of the purpose of these funds and any conditions attached to these funds and the purchasing of the new facility.

Any due diligence carried out by Homes England in relation to the granting of this fund to BCHA

Response

You may wish to contact the Local Authority who may hold information.


