Thank you for your email of 14 December 2020, following our most recent reply of 8 December 2020 inviting you to refine your request.

You originally asked for the following information:

"I would like to know how many Military Veterans there are who were unfortunate enough to leave service before 1975 and not receive a pension".

On 5 October 2020 you refined your request as follows:

"Would it be possible to ascertain the numbers between 1955 and 1980 or even 1960 and 1980, which hopefully would give some idea to the numbers involved which I could then pass on to my Member of Parliament and other interested parties".

On 13 November 2020 you refined your request as follows:

"To only for veterans of the Royal Navy for the same date period."

You have now refined your request to the following:

"I wish to refine my request as per your paragraph

"We may be able to provide the numbers of Royal Navy service leavers since 1970 or the numbers in receipt of pension under a particular pension scheme if you would find that of use."

Can you provide details of the following: Immediate pension scheme for 1970 to April 75 and the AFPS for 1975 onwards."

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence and I can confirm that some information in scope of your request is held. However, I must advise you that to answer your refined request would still exceed the appropriate cost limit.

Section 12 of the FOI Act makes provision for public authorities to refuse requests for information where the cost of dealing with them would exceed the appropriate limit, which for Central Government is set at £600. This represents the estimated cost of one person spending 3.5 working days in determining whether the department holds the information, locating it, retrieving it and extracting it.

Answering your request would involve the cross-referencing of many thousands of Service Numbers against pensions in payment. This would not include those who received a pension but had subsequently died so further searches would also then need to be carried out. The number of veterans who served in the Royal Navy during the time periods specified would run to many thousands and cross referencing these would far exceed the cost limit.

As previously explained, we have an obligation under Section 16 (Advice and Guidance) of the FOIA to offer as much advice and assistance as is reasonably practicable and as such we would normally suggest ways in which you can refine your request to bring it below the cost limit. However, the MOD is unable to provide any information which would assist you as we only hold electronic data for service leavers from 1970 onwards and this is subject to the same requirement to cross reference for pension information.

In my last response I noted that we may be able to provide the numbers of Royal Navy service leavers since 1970 or the numbers in receipt of pension under a particular pension scheme if you would find that of use. Regarding your most recent refinement, I should explain that there is no 'Immediate Pension Scheme'. Prior to 1975, personnel had to complete a minimum of 22 years to receive pension benefits, there was no preserved pensions at this point. Furthermore, Armed Forces pensions from 1975 onwards are paid under the Armed Forces Pension Scheme 1975 (AFPS 75), the Armed Forces Pension Scheme 2005 (AFPS 05) and the Armed Forces Pension Scheme 2015 (AFPS 15).

Once again, if you wish to further refine your request, we may be able to provide answers to the following questions if you would find that of use:

- a) the number of Royal Navy service leavers since 1970
- b) the number of Royal Navy service leavers in receipt of a pension under AFPS 75
- c) the number of Royal Navy service leavers in receipt of a pension under AFPS 05
- d) the number of Royal Navy service leavers in receipt of a pension under AFPS 15
