Thank you for your letter of 29 December 2020 to the Ministry of Defence (MOD) requesting the following information:

"The GOTT offer to transfer remains complex to understand. The fact that a few of our members will soon be reaching 60 which is the qualifring age to transfer, we request that you as a duty of care and led by the Freedom of Information Act to please divulge the following information:

This information is crucial to compare the AFPS pension against the Gurkha Pension Scheme and will also be required to present to our respective MPs. We do understand that this may not be accurate, but an average figure based on the information sought will be adequate for our purpose."

A search for the information has now been completed within the MOD and I can confirm no information in scope of your request is held.

Under section 16 of the FOIA (Advice and Assistance), you may be interested to know that there is no database listing all those who opted for AFPS75 deferred pension benefits under the Gurkha Offer to Transfer (GOTT). Every amount of pension is individual to each Gurkha as there is no set rate for a rank with a particular number of years' Service, nor are there any commonalities to work against as pension rates are dependant upon rank and the year of discharge, which would be different for each Gurkha.

To process pension entitlements, Veterans UK extract all those who are going to be age 60 within a six month period from the Far East & Nepal Administration System (FENAS), request their pension file and check individuals files to see if they opted to transfer into AFPS at the deferred pension age of 60. If they made a positive election to transfer in 2008, then Veterans UK calculate what their deferred AFPS pension will be from age 60. You should note, however, that Gurkhas do not receive the same deferred pension rate as their UK equivalent. This is because a Gurkha receives an immediate Gurkha Pension on discharge after 15 years' Service, whereas their UK equivalent with 15 years' Service has to wait until age 60 to receive their pension. Therefore, when a Gurkha transfers at age 60 they receive a percentage of the deferred pension to reflect the fact that they have been receiving a Gurkha pension from discharge until they reach 60 and move across to the AFPS.

Unfortunately, due to the broad nature of your request, I am not able to suggest ways in which you can refine your request.
