Thank you for your letter of 15 February 2021 to the Ministry of Defence (MOD), requesting the following information:

- "1. A copy of my full Army Service Document
- 2. A copy of my full Army Medical Records (
- 3. A copy of the Military Covenant which governs the service of any of any ex Service Person
- 4. A copy of the Army Records for my entitlement to a Service Pension, with dates for entitlement and a cost estimate.
- 5. A copy of the MOD procedure and any forms for claiming a Service Medical Pension I suffer from PTSD and several medical conditions due to my service.
- 6. Information in how the MOD can help me with the above under the Covenant Principle"

A search has now been completed within the MOD for the information requested.

I should first explain that Questions 1,2 and 4 of your request relate to your personal data, and in order not to breach Data Protection principles, the Department, under section 40(5B)(a)(i) of the FOI Act, is unable to confirm or deny whether any information is held within the scope of this part of your request. This is because if held, this information would be exempt under Section 40 (2) of the FOI Act in line with Data Protection Legislation. Section 40 is an absolute exemption and not subject to a public interest test.

Notwithstanding the above, under Section 16 of the FOIA (Advice and Assistance), you do have the right to request access any personal data which may be held by the Department under the Data Protection Act 2018. As such, I have passed this part of your request to the Department's Subject Access Request (SAR) Team who will contact you in order to establish if any such information exists.

I am treating Questions 3, 5 and 6 as a request for information under the Freedom of Information Act 2000 (FOIA).

In answer to Questions 3 and 5, I can confirm this information falls entirely within the scope of an absolute exemption under Section 21 of the FOIA as it is reasonably accessible by other means. As Section 21 is an absolute exemption, there is no requirement to consider the public interest in making the decision to withhold the information.

Please note that any request for an internal review should be made within 40 working days of the date of this response.

If you remain dissatisfied following an internal review, you may raise your complaint directly to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not normally investigate your case until the MOD internal review process has been completed.
