 AB members were reassured by officials that appropriate funding for these pupils would be in place.

- Members noted the capacity that Ashton Park and Ashton Vale provided to the trust.
- Members recognised that these places were needed ahead of September.
- AB members were cognisant of the need for SEND places in Bristol and the risk these
  pupils may be placed into provisions that do not meet their needs if resources bases are
  not utilised.

Members queried the mix of ASC and pupils with a disability. They were reassured by
officials that the trust has reviewed the ECHPs of the pupils due to join the resource
base and the places would primarily be for pupils with ASC as their primary need.

Further actions required: Project lead to inform the school and trust.

- AB members were aware that Southerly Point MAT has a large number of small rural schools and therefore may not get the same benefits of scale as other MATs.

- AB members wanted to recognise the support that should be given to staff during this transition.
- AB members recommended a review of the trust's growth plans at primary level.

 Members discussed the potential for transfer funding and ensuring transparency in the level of funding awarded to SAT to MAT transfers, officials noted there is a case to make bid for additional funding in exceptional cases.

#### School Improvement

• AB members commented that they hoped this trust change would, in time, result in Equa being able to support other schools in the area.

#### Other

• AB members noted the representation from the nursery and took the view that it would be very pragmatic to maintain the preschool as an effective feeder for the school however it would not be appropriate to make its continued operation on site a formal condition of approval. Officials would continue to liaise with parties on the matter.

**Notes of discussion:** This significant change is in response to the shortage of secondary school places in Bristol for September 2021. This is in part a retrospective change as most of the physical expansion works have previously taken place. Capacity assessments demonstrate that the school can accommodate the forecast pupil numbers as they move through the school. The trust has recruited additional staff within the school and trust central team to prepare for the change. The RSC office has discussed with the trust the health and safety arrangements for the site, and these considerations have been built into the business plan. The RSC office is content that the consultation requirements have been met.

**Further actions required:** Project lead to inform the school and trust. Project lead to communicate to the trust and Local Authority that any requests for future expansions at this school will require detailed health and safety reports on both capacity and transport planning and approval of such requests is not guaranteed.

**Project:** Whether to approve a significant change application for Bristol Metropolitan Academy, **Bristol** (Cabot Learning Federation) to increase physical capacity from 945 to 1060.

**Decision type:** Significant change

RSC decision: approved via RSC correspondence log on 2 August.

Conflicts: None

**Notes of discussion:** This significant change is in response to the shortage of secondary school places in Bristol for September 2021. It was noted that this is a retrospective change and the work to increase capacity has already been undertaken. Staffing has been increased to ensure that educational quality is not compromised, and health and safety implications have been considered. The RSC office is content that the consultation requirements have been met.

**Further actions required:** Project lead to inform the school and trust. Project lead to communicate to the trust and Local Authority that any requests for future expansions at this school will require detailed health and safety reports on both capacity and transport planning and approval of such requests is not guaranteed.

**Project:** Whether to approve a significant change application for John Cabot Academy, **South Gloucestershire** (Cabot Learning Federation) to increase physical capacity from 1056 to 1400.

**Decision type:** Significant change

**RSC decision:** approved via RSC correspondence log on 2 August.

Conflicts: None

**Notes of discussion:** This significant change is in response to the shortage of secondary school places in Bristol for September 2021. Additional accommodation will be created on the John Cabot site to house the 6th form students, with the construction of a temporary classroom block. The trust has confirmed that if for whatever reason the permanent 6<sup>th</sup> form building is not built within 5 years, that the Academy will be able to accommodate all the students within this revised capacity and this is illustrated in the capacity assessments. The educational impact of the change was considered. It was noted that the trust will continue to provide the existing post-16 curriculum offer and there will also be timetable benefits for housing all the post 16 on one site. Health and safety and travel implications have been planned for by the Trust, with mitigations adopted where appropriate.

The consultation process was reviewed, and the RSC was content that a fair and open consultation has taken place and that those who wished to make representations were able to do so. It was acknowledged that a public meeting may have been a useful exercise, however mandatory consultees were notified of the proposed changes by letter and individual meetings were offered to discuss the proposals. Furthermore, post 16 students and their families were actively engaged in the development of plans.

**Further actions required:** Project lead to inform the school and trust. Project lead to communicate to the trust and Local Authority that any requests for future expansions at this school will require detailed health and safety reports on both capacity and transport planning and approval of such requests is not guaranteed.

- RSC note that this has been a long-standing decision, but due to the urgency of needing to take a decision ahead of the new academic year this application was considered outside of an AB meeting. All AB members were informed of this project and were given the opportunity to share their views. ask questions, and raise concerns ahead of an internal meeting to discuss this project.
- RSC recognised that Acorn have been working been working with RDD SW and EFSA to get to this point.
- It was noted that this is a decision in principle the final decision will be subject to ministerial approval for a funding package to support the transfer.
- RSC reiterated that this is the strongest trust opportunity for these schools and that the two trusts have been working closely for a sustained period.
- RSC noted that Acorn are a high-performing trust who have been providing significant school improvement capacity and support to the schools within SPA, over a significant period. This support has recently been supplemented by support from the Department via the Emergency fund.
